# <u>O R D E R</u>

[Per :- Justice P.R. Bora, V.C.]

1. Heard Shri M.S. Karad, learned counsel for the applicants in all these matters and Shri V.R. Bhumkar, learned Presenting Officer for the respondent authorities in all these matters.

2. In view of the fact that in all these matters the facts and prayers made are identical, we have heard all these matters together and deem it appropriate to decide these matters by this common order.

3. The public health department of the State had resolved to fill in the vacant posts of Multipurpose Health Workers (Male) (50%) for every districts of the State. Therefore, directions were issued to the District Malaria Officers of all the districts to issue advertisements to fill in the vacant posts in Accordingly, the District Malaria their respective districts. Officers of the respective districts wherein vacant posts were available issued the advertisement inviting applications from the eligible candidates to be appointed on the post of Multipurpose Health Workers (Male) (50%). The present applicants accordingly had applied for the said post in respective Districts. The aspiring candidates were required to undergo a written test and the candidates, who scored 45% and above marks were named as eligible candidates. The eligible candidates were interviewed by the Committee and the candidates, who were in order of merit were called upon to submit the eligibility documents in original for verification. Since all these candidates were claiming the advertised posts from the quota of seasonal spray workers, all of them were under an obligation to submit the experience certificates in the prescribed format evidencing that they have worked for more than 90 days' as Seasonal Spray workers. It is the case of these applicants that they succeeded in the written examination as well as further selection process and were required to submit their documents for verification at the respective District Health Offices of Malaria where they were appointed.

4. On 10.08.2021 the Assistant Director of Health Services (Malaria), Pune issued a letter to all the Assistant Directors Health Services (Malaria) laying down certain guidelines for verification of the experience certificates issued in favour of the Seasonal Spray Workers. At the stage of documents verification, some complaints were received to the effect that the experience certificates issued by the then District

Malaria Officer, Beed are bogus and false. One written complaint was also received in that regard from Advocate Bhausaheb Latpate. The respondent No. 2, therefore, constituted a committee to conduct an enquiry in respect of the experience certificates issued in favour of the respective applicants. The said committee conducted the enquiry and held the 'experience certificates' of the present applicants invalid. The committee named 69 candidates having produced the false experience certificates. Thereafter all the District Malaria Offices were directed not to give effect to the appointment of the candidates whose names are included in the list of 69 for having produced the false experience certificates. Aggrieved by the said order the applicants have approached this Tribunal praying for quashment of the said communication by holding the experience certificates submitted by the present applicants valid. Consequent directions are also souhgt against the respondents to appoint the applicants in respective districts where their names have been recommended.

5. It is the contention of the applicants that the experience certificates produced by them are genuine and they have actually worked as Seasonal Spray Workers during the period as stated in their certificates. The applicants have placed

on record the copies of their attendance sheets as well as the payment sheets in order to buttress their contention that the experience certificate submitted by them are genuine one.

6. Respondent Nos. 1 to 7 have filed their joint affidavit in reply to resist the contentions raised by the applicants in their OAs and the prayers made therein. The Chief Administrative Officer in the office of Deputy Director of Health Services, Latur Circle, Latur namely Dnyandeo Vasantrao Karwar has sworn the said reply. The respondents have denied the very fact asserted by the applicants that they have worked for more than 90 days as Seasonal Spray Workers. It is the contention of these respondents that the seniority list as on 01.01.2015 of the Health Workers did not contain names of these applicants. It is further contended that the committee constituted as per the directions issued by the Joint Director of Health Services, Pune when ascertained the information as about sanctioned mandays for District Beed, it was noticed that appointments were given to these applicants without sanctioned mandays. It is further alleged that there is no entry about the experience certificates issued in favour of these applicants by the respective offices. It is further contended that appointment orders of these applicants are not on record. It is further

contended that the names of the applicants are not existing in the seniority lists of the year 2014 as well as 2015. It is further contended that based upon the report of 03 Members committee the Joint Director of Health Services, Pune who in turn issued the necessary directions to the Malaria Offices at the respective districts.

7. Shri M.S. Karad, learned counsel appearing for the applicants submitted that the applicants have placed on record sufficient evidence to prove their eligibility. Learned counsel pointed out that not only available attendance sheets but the particulars as about the payment received and the number of Treasury bills are provided by these applicants. Learned counsel submitted that seniority list has also been placed on record by the applicants. Learned counsel pointed out that the extracts of the inward and outward registers are also produced on record by the applicants. Learned counsel submitted that the applicants have placed on record overwhelming evidence showing that they do possess the experience of working for more than 90 days as Seasonal Spray Worker. Learned counsel submitted that the respondents though have lodged the FIR against the applicants naming them as accused persons, during the entire investigation no incriminating material is received to

the investigating officer. Learned counsel further submitted that the investigating officer has candidly recorded that the allegations made against the applicants in the complaint received against them are absolutely false. Learned counsel further submitted that the investigating officer has submitted 'C' summary report before learned Magistrate. Learned counsel submitted that in view of the clean chit given by the investigating officer there has remained no impediment for issuance of appointment orders in favour of the applicants. Learned counsel in the circumstances prayed for setting aside the impugned orders and for issuance of directions against the respondents for extending all the consequential benefits.

8. Learned Presenting Officer appearing for the State authorities submitted that in the enquiry conducted by 03 Members committee it is revealed that the certificates produced by these applicants were not in the prescribed format and were lacking all the necessary particulars. Learned P.O. submitted that though the investigating officer submitted 'C' summary report, the Hon'ble Court has not accepted the said report. He further submitted that the documents on record sufficiently prove that the applicants have attempted to prepare and file false experience certificates. Learned P.O. submitted that valid experience certificate was of utmost importance for appointments of the applicants and since the applicants have failed in proving their experience certificates to be valid, none of them is entitled for appointment. Learned P.O. further submitted that now another recruitment process is also on the verge of its completion and in such circumstances he prayed for dismissal of these applications.

9. We have duly considered the submissions made on behalf of the applicants as well as the respondents. It is not in dispute that the applicants have successfully passed the written examination and the interview and have secured place in the list of eligible candidates to be recommended against the respective vacancies in the respective districts. As is revealing from the documents on record and the pleadings of the parties, at the time of document verification, which is practically the final stage before issuance of the order of appointment, the complaint was received to respondent No. 1 alleging malpractices in issuance of the experience certificates produced by the applicants. On such complaint the respondents had constituted a three member committee.

10. As contended by the respondents, the said committee in its report recommended the Government not to

consider these applicants/candidates for their appointment to the subject posts. Respondents have however, not placed on record the report submitted by the said committee. Though the report of 03 Members Committee is not filed on record, which we reiterate that must have been filed on record, in the letter dated 03.10.2022 written by the Under Secretary of the State to the Commissioner of Health Services, the conclusions recorded by the said committee are reproduced. Those are as under:-

(i) that 69 experience certificates given by the District Maleria Officer, Beed during the period between 2016 and 2020 are not in accordance with the letter dated 22.10.2010 issued by the Joint Director of Health Services ((Malaria, Faleria and Waterborne disease), more particularly in consonance with the guidelines given for seasonal spray staff.

(ii) that the names of the present applicants since were not existing in the seniority list of 2014 and 2015 the applicants were not eligible for to be given work but in spite of that the experience certificates are issued.

(iii) the appointment orders of the seasonal spray workers are not find on record.

(iv) there is no noting or entry of the experience certificates issued in favour of the seasonal workers in the outward register. (v) there is no record i.e. duly attested original musters of the period in which the seasonal workers claimed to have worked.

(vi) there is no report of the work performed by the seasonal workers namely drug spray survey.

(vii) no office copies of the bills submitted to the Treasury in respect of the wages paid to the seasonal workers.

(viii) it is noticed that no individual bills are drawn but the consolidated pay bills are submitted to the Treasury.

(ix) there is no record whether the wages of the seasonal employees were paid in cash or deposited in their respective bank accounts.

(x) non-compliance is noticed on part of the seasonal employees in submitting the relevant documents.

(xi) all 69 experience certificates are found to be bogus.

(xii) the following officers are responsible for issuing false experience certificate to the seasonal employees:-

- (1) Dr. K.S. Andhale
- (2) Shri Jivan Baburao Sanap
- (3) Shri J.K. Satpute

11. One of the applicants namely Shri Sushilkumar Babasaheb Rakh has filed his rejoinder affidavit to the affidavit in reply filed on behalf of the respondents. In the rejoinder he has denied all the objections and allegations made against the applicants and has placed on record several documents supporting the case of the applicants. The respondents also have filed thereafter one short affidavit and have placed on record certain documents.

12. We have carefully gone through the contents of the rejoinder affidavit submitted on behalf of the applicants and shot affidavit submitted by the respondents. We have also gone through the documents placed on record. The applicants have at the time of filing the O.As. have placed on record copies of the pay bills, muster roll, account roll, payroll, extract of bill register, token register and copy of seniority list. In the affidavit in reply filed on behalf of the respondents they have not denied or disputed any of these documents. Nothing is placed on record by the respondents to show that seasonal appointments given to the applicants were not given according to the seniority list maintained. The applicants have also placed on record the seniority list. It is not the case of the respondents that the seniority list placed on record by the applicants is bogus. Copies of the muster roll, pay bills, treasury bills have also not been denied or disputed by the respondents.

13. The documents filed by the applicants whether are forged could have been examined bv genuine or the Treasury bills are produced on record by the respondents. applicants. Had the treasury bills falls or may not be pertaining to the wages paid to the applicants, the respondents would have certainly taken serious objection in that regard and could have proved falsity in the claim of the applicants. The respondents, however, have not raised any objection to the said documents. The respondents have not denied and disputed any of the said documents. When copies of the pay bills are placed on record by the applicants, it was not impossible for the respondents to verify the particulars from the original record and on this count it was quite possible for the respondents to expose the applicants and prove fallacy in their claims.

14. It is significant to note that in the 'C' summary report submitted by the investigating officer to the learned Magistrate, he has specifically submitted that during investigation the documents which were seized and the documents which were scrutinized by him leave no doubt that the applicants have worked in the relevant period and accordingly the experience certificates are issued in their favour. The Investigating Officer has made a candid statement that in the seniority lists of the year 2017 the names of all these 69 candidates were noticed by him. It is further recorded by the Investigating Officer that on the wages sheets there are signatures of the candidates and they have admitted the payment received to them accordingly. The Investigating Officer has further candidly opined that on the basis of the facts revealed in the investigation conducted by him it is difficult to accept the allegation that the experience certificates produced by the applicants are bogus or concocted and the complaint seems to have been given because of some misunderstanding. For the above reasons the Investigating Officer has prayed for accepting 'C' summary report.

15. The applicants have also placed on record the copies of the statements recorded during the course of investigation by the Police Authority. The said statements are of the officers working in the respective malaria offices. 03 statements are there on record. One Shri Ram Kolapkar, who was at the relevant time working in Patoda region. According to the statement given by him the workers who have been named by him were working under his supervision when he was Health Supervisor. Said Kolapkar has produced before the Police the data in respect of working days of these applicants from the record. The another statement is of Shri Shankar Kadam, who is still working in District Malaria Office at Beed as Health Supervisor. He has stated before the Police that when he was in Kaij region during 2015-16 the candidates whose names are mentioned in the list have worked under him. It is further stated by the said officer that the attendance registers which were shown to him bear his signature also.

16. In the affidavit in reply it is the contention of the respondents that the Health Supervisors working in Primary Health Centers have not certified the attendance register of the concerned Seasonal Workers i.e. the present applicants. We have referred to the statements recorded of 02 Health Supervisors, who have stated in their police statements that the applicants had worked in the respective offices as Seasonal Spray Workers and that the record was also maintained in that The objections raised by the respondents in their regard. affidavit in reply have been answered by the applicants by placing on record the relevant documents. In order to substantiate their contention that all of them had worked for more than 90 days', the applicants have placed on record plenty of evidence sufficient to accept their claim that they had actually worked for the required period as Seasonal Spray

Workers as prescribed in their experience certificates. As against it the respondents have utterly failed in establishing that the experience certificates of these applicants are bogus or forged. The applicants have when satisfactorily discharged the burden on them, to prima-facie prove their contention, the respondents have failed in substantiating their allegation that the experience certificates of these applicants are forged. The 'C' summary report submitted by the Investigating Officer in the matter of FIR registered against these applicants on allegation of procuring forge certificates cannot be kept out of consideration on the ground that the learned Magistrate has not yet accepted it. The aforesaid circumstance can be interpreted in favour of the applicants also holding that the learned Magistrate has not yet rejected the 'C' summary report. The entire thrust of the respondents is on the enquiry carried out by 03 Members' committee. However, as we have noted hereinabove, the respondents have not filed the report of the said committee on record.

17. Relying on the judgments of the Hon'ble Supreme
Court in the case of S.S. Balu & Anr. vs. State of Kerala & Ors.,
2009 (2) SCC 479 and another in the case of Pitta Naveen
Kumar & Ors. vs. Raja Narasaiah Zangiti, 2006 (10) SCC 261, it

has been argued by the learned C.P.O. that above all it is the prerogative of the employer State whether to appoint the persons like the applicants whose credentials are felt doubtful, though their names may be existing in the list of the selected/recommended candidates. There cannot be a dispute about the ratio laid down in both the aforesaid judgments. It is well settled that mere selection does not give any vested right to the selected candidates to be appointed. The same principle has been reiterated in the matter of **S.S. Balu** (cited supra) that there is no indefeasible right to the appointment and the Government is free to fill up or not to fill up the vacancies.

18. It has been pointed out by the learned counsel for the applicants that the Hon'ble Supreme court in the case of **S.S. Balu** (cited supra) has also observed that the discretion vested in the State, however, cannot be exercised by it arbitrarily. According to learned counsel for the applicants, the conduct of the respondents in the instant matter of not issuing appointments to the applicants, despite having included their names in the list of selected candidates, is the example of arbitrariness on part of the respondents.

19. In the instant matter, as has come on record it is undisputed that the applicants have successfully undergone the

selection process and their names were included in the list of selected candidates. It is also undisputed that the only reason for not considering the applicants for their appointments is that some complaints were received in regard to the experience certificate submitted by these applicants and that in the inquiry carried out by the respondents in that regard through 03 members committee, substance was found in the complaints so received. We have elaborately discussed hereinabove that it was quite possible for the State to substantiate the allegation as aforesaid by placing on record the necessary material. As observed by us, the respondents have utterly failed in discharging the burden on them. As against it, the applicants have produced on record sufficient documentary evidence.

20. It is true that merely because the name of the candidate finds place in the select list it would not give him indefeasible right to get the appointment as well. In the present matters however, core issue is that the respondents have declared the applicants ineligible for their appointments on the posts of Multipurpose Health Worder (Male) (50%) holding that they do not possess the experience certificates in the appropriate format or in accordance with the parameters laid down in that regard. We have elaborately discussed hereinabove as

about the failure on part of the respondents to substantiate their said contention, whereas the applicants have sufficiently proved the genuineness in their experience certificates. In the circumstances, the order passed by respondent No. 4 thereby declaring the applicants ineligible cannot be sustained and deserves to be set aside. Consequently, the respondents henceforth may not decline the candidature of the present applicants for their appointments on the post of Multipurpose Health Worker (Male) (50%) on the basis of their experience certificates.

21. As has been submitted by learned P.O. based on the averments in the affidavit in reply filed on behalf of the the recruitment process respondents. in pursuance of advertisement of 2019 has been concluded. However, as per the submissions made on behalf of the applicants some posts are still unfilled. It is also matter of record that subsequent recruitment process was commenced by respondents vide advertisement dated 15.03.2023. The respondents have filed pursis on record contending therein that the said recruitment has process also been successfully completed and the appointment orders are issued to the candidates who are in all respect held eligible for their appointments. In this regard also

according to the information of the applicants, all the posts have not yet been filled in and the vacancies are there in every district. The information about vacancies in the Beed district is placed on record by the applicants. The applicants have submitted the information received to them under Right to Information Act today to the effect that 21 posts are vacant in the Beed district of the Multipurpose Health Worker (Male) (50%). The document so received to the applicants under RTI is taken on record.

22.According to the learned counsel appearing for the applicants there are vacancies in all the districts in the State as similar to the district of Beed and in the circumstances according to him present applicants can very well be accommodated against the said vacant seats. As stated hereinabove, though it is a settled legal position that the name of the candidate may appear in the select list but he has no indefeasible right to get the appointment, it is also well settled that the respondents cannot deny to consider any such candidate for his appointment on unsustainable or unreasonable ground. If the appointment is to be denied to such candidate, such decision of the respondents must be based on some sound reasoning. If the vacancies are available and when Government has declared its intention to fill up the said posts by issuing an advertisement even in the year 2023, the respondents are under an obligation to consider the present applicants for their appointments against the vacant seats having regard to the fact that in the recruitment of 2019 they have been deprived of such appointments on some unreasonable ground.

23.The respective applicants have filed respective M.A.NO.441/2023 IN O.A.NO.659/2021 M.A.NO.442/2023 IN O.A.NO.661/2021 M.A.NO.443/2023 IN O.A.NO.183/2022 M.A.NO.444/2023 IN O.A.NO.185/2022 M.A.NO.445/2023 IN O.A.NO.186/2022 with a prayer that the applicants be permitted to bring on record the subsequent developments occurred in respect of the subject matter during pendency of the As contended in the Misc. Applications during the OAs. pendency of the OAs the respondents had issued an another advertisement on 15.03.2023, thereby inviting applications for filling in vacant posts of Multipurpose Health Workers in the respective regions. The respondents in that regard have filed prusis on record on 20.02.2024 contending therein that the said recruitment process has been completed and the process of giving appointments is in progress. Yesterday i.e. on

20.03.2024 the learned P.O. placed the on record communication received to his office from the Joint Director Health Services, Pune, wherein it is stated that in pursuance of the advertisement of 2023 the candidate selected on the post of Multipurpose Health Worker (Male) Group-C, who are found eligible on verification of the documents have been given appointments. The respondents however, have not provided the further information as to how many appointments are issued and how many posts are still to be filled in. On a query, learned P.O. Shri Bhumkar, however, clarified that the appointments are issued only to such candidates who are found eligible after verification of the documents. Therefore, there appears reason to believe that all the posts have not yet been filled in.

24. For the reasons elaborated hereinabove, we are inclined to allow the present Original Application. Hence, the following order is passed:-

#### <u>order</u>

(i) The order dated 11.10.2021 issued by respondent no. 4, thereby declaring the applicants ineligible for to be appointed on the post of Multipurpose Health Workers (Male) (50%) by holding the experience certificates submitted by the applicants to be not in accordance with the parameters laid down, is quashed and set aside. Consequently the applicants are held

entitled to be appointed on the post of Multipurpose Health Workers (Male) (50%).

(ii) Respondents are directed to consider the applicants for their appointments on the vacant posts in respective districts.

(iii) Original Applications stand allowed in the aforesaid terms.No order as to costs.

(iv) Since the OAs have been allowed and disposed of, the Misc. Applications also stand disposed of.
