On 28.10.2021 an advertisement was published by the Maharashtra Public Service Commission (for short the M.P.S.C.) for the recruitment on the posts of Assistant Section Officer, Sales Tax Inspector and Police Sub Inspector. Total 1085 posts were to be filled in. All the applicants filled in the examination form and appeared for the preliminary examination. On 2.3.2022 the M.P.S.C. published the first answer key. On 5.5.2022 the M.P.S.C. published the second answer key and while publishing the said answer key deleted the question nos. 8, 12, 13, 24, 32, 35, 46 and 73, whereas the answers to question nos. 20, 54 & 89 were modified. It is the grievance of the applicants that due to deletion of questions and modification in the answer key the grand total marks secured by the

applicants got adversely affected, their marks were reduced and they could not secure the cut-off marks fixed for making the candidate eligible to appear in the main examination.

3. Shri Joshi, learned counsel appearing for the applicants vehemently argued that as contended by the M.P.S.C. in its affidavit in reply more particularly in paragraph no. 14 of the affidavit in reply when the first answer key on the official website of the Commission was published as per the answers provided by the subject experts, why the M.P.S.C. indulged in referring the said answer key to the another subject experts as contended in paragraph no. 15 of the affidavit in reply. The learned counsel submitted that when the first answer key was also prepared as per the answers provided by the subject experts and the second time also the answers are provided by the subject experts, the question arises as to opinion of which subject experts shall prevail. The learned counsel strenuously argued that because of the casual approach of the M.P.S.C. the ultimate sufferers are the unemployed youth like the present applicants. The learned counsel submitted that there is no policy fixed in this regard and decisions are taken as per the whims of the authorities of the M.P.S.C. The learned counsel further submitted that the M.P.S.C. has also failed in considering that because of

deletion of 08 questions while preparing the second answer key the candidates who might have correctly answered the said 08 questions in conformity with the first answer key when have suffered the loss of 08 marks, the candidates who might have answered the said questions contrary to the answer key and for that who were likely to suffer negative marks for answering the said questions wrongly will be at advantageous position. The learned counsel submitted that the issues raised by the applicants deserve to be considered for the reason that they are prejudicially affecting the interest of many candidates like the present applicants. The learned counsel submitted that the said issues can be decided in the final hearing of the present matter, which may definitely require some more time. The learned counsel submitted that the mains examination is scheduled on 9.7.2022. He further urged that the applicants however have certainly made out a strong prima-facie case for giving directions to the M.P.S.C. to provisionally permit the applicants to appear in the mains examination subject to final outcome of the present O.A. The learned counsel therefore prayed for grant of interim relief as prayed for in the application.

4. The M.P.S.C. has filed the affidavit in reply opposing the contentions raised in the application. The M.P.S.C. has questioned the locus of the present applicants in filing

the application stating that the applicants have failed to demonstrate whether they have raised objections to the answers in first answer key, which they have challenged in the present application. It is further contended that after the first answer key was published on the official website of the M.P.S.C. the objections were invited to the said answer key in response to which the objections were received on various questions. It is further contended that all the objections received from the candidates were referred to the subject experts for their opinion and after duly scrutinizing and verifying all such objections and references of the candidates, the second and final answer key was published by the M.P.S.C. on 5.5.2022. It is further contended that after publication of the final answer key it is not permissible for the candidates to raise further objection as same would be then unending process. It is further contended that because of deletion of the certain questions, no prejudice can be said to have caused to the applicants. The M.P.S.C. has therefore prayed for rejecting the prayer of interim relief.

5. I have carefully considered the submissions advanced on behalf of the applicants, as well as, the respondent M.P.S.C. I have also perused the documents filed on record. Insofar as the objection raised for referring the answer key to the subject experts second time is

concerned, as on today the law stands settled that the Courts or the Tribunals shall be very slow in causing any interference in the opinion given by the subject experts. At the interim stage undisputedly the said issue cannot be gone into. The second issue which has been raised about loss caused to the candidates because of subsequent deletion of 08 questions from the question paper and the answer sheet is concerned, I am not prima-facie convinced that any case is made out by the applicants to grant interim relief as has been prayed by them.

6. It is the contention of the applicants that all of them have secured the marks in the preliminary examination marginally less than the cut-off marks. It has been argued that the answers provided in the first answer key are infact the correct answers and if the answer sheets of the applicants is assessed on the basis of said answer key all of them are likely to cross the bar of cut-off marks. I have noted hereinabove that the law as on today holds the field that this Tribunal cannot examine the correctness of the opinion expressed by the experts on the subject. In the circumstances, it does not appear to me that any case for interim relief is made out by the applicants, though the issues raised by them certainly deserve consideration at the time of final hearing of this O.A. The prayer for interim relief is therefore rejected.
