- 4(4)(2) & 4(5) of the Maharashtra Government Servants Regulation of Transfers and Prevention of Delay in Discharge of Official Duties Act, 2005 (hereinafter referred to as the said Act for brevity) and hence the transfer order is to be stayed.

2. The applicant is working as ad-hoc Assistant Professor, Department of Community Dentistry in Government Dental College and Hospital, Aurangabad since 04.02.2020. She was first appointed on the said post vide order dated 01.02.2020. The aforesaid order was for the limited period of 120 days. Thereafter also the applicant was issued with the similar appointment orders time to time and the applicant has been thus discharging duties of the aforesaid post in the Government Dental College & Hospital, Aurangabad since last more than 3 years. It is the grievance of the applicant that the respondents in the meanwhile intended to make fresh appointments that too on ad-hoc basis and as such, the applicant is required to file the present Original Application before this Tribunal.

- 3. Learned counsel for the applicant submits that law is well settled that one ad-hoc appointee cannot be substituted by another ad-hoc appointee. Learned counsel submitted that the applicant is not claiming any relief other than that she may not be replaced with another ad-hoc employee and shall be continued till the duly selected candidate is appointed in her place.
- 4. Learned P.O. submitted that in the affidavit in reply factual contentions as are raised by the applicant are not denied by the respondents. The respondents have however made it clear that on the basis of the orders issued previously, the applicant cannot claim regularization in the services. Learned P.O. submitted that appointments of the applicant and the similar other candidates are made by giving those candidates clear understating that their appointments will remain in force till the regularly selected candidates are appointed on their post.
- 5. Learned P.O. further pointed out that in the order of appointment issued in favour of the applicant, it has been clearly mentioned that if

regularly selected candidate is appointed on the said post through MPSC or if the said post is filled candidate, bonded then the applicant's appointment shall be terminated. Learned P.O. on instruction made a statement that the respondents are not going to fill the post occupied by the applicant by appointing another ad-hoc employee and it is only after availability of the candidate from MPSC that post will be filled in.

- 6. From the statement so made, it is quite evident that the applicant is not likely to be substituted with another ad-hoc employee.
- 7. In view of above, the O.A. stands disposed of without any order as to costs.
