3. Applicants are working in the Government Ayurvedic College at Nanded. It is the case of the applicants that after the State Government took a decision that the Government offices would work for 5 days in a week and every Saturday & Sunday will be non-working day, the applicants have not attended the duties on Saturdays. Vide impugned order the applicants were informed to make application seeking leave on the Saturday on which

they had been absent or else they will be held to have unauthorizedly remained absent on the said days and that will be treated as unauthorized leave and wages of the said period would be deducted. Against the said order the present Original Application has been filed.

4. Shri Santosh C. Bhosale, learned counsel appearing for the applicant submitted that the applicants are members of non-teaching staff. Their presence, therefore, may not be mandatory on non-working days, though the 'Medical Services' fall in the category of 'Essential Services' and, as such, they were not required to attend the duties on Saturdays. Learned counsel submitted that the order passed on 28.10.2020 is in violation of the Government Resolution dated 24.2.2020, whereby the Government itself has declared as 5 days week.

5. Shri V.R. Bhumkar, learned Presenting Officer appearing for the respondents opposed the submissions made on behalf of the applicants. Learned P.O. submitted that in the Government Resolution itself it has been clarified that the



decision taken by the Government to make 5 days week would not be applicable to the Institutions providing essential services and illustrative list is provided as Annexure 'A' to the said G.R. Learned P.O. invited my attention to item 9 in the said Annexure 'A' which refers to the essential services and the educational institutions, wherein it has been clarified that the G.R. dated 24.2.2020 may not be applicable to Government Medical Colleges and Technical Institutions. It is not in dispute that the applicants are employees in the Government Ayurvedic College. It is thus evident that the Government Resolution dated 24.2.2020 may not apply to the employees of the said Medical College. In the circumstances, it does not appear to me that any illegality has been committed by the respondents in issuing directions vide the impugned order. Hence, the following order: -

**ORDER**

- (i) Original Application is rejected.
- (ii) No order as to costs.
- (iii) It would be, however, open for the applicants to make application to the

appropriate authority as indicated in the impugned order seeking leave pertaining to the Saturdays on which they remained absent. If such application is filed by the applicants, the authority concerned shall consider the same in accordance with law.

Heard Shri N.L. Choudhary, learned counsel for the applicant and Smt. M.S. Patni, learned Presenting Officer for the respondent authorities.

2. In the present application the applicant has prayed for following relief: -

“C] By issuing a appropriate order or directions in the like nature, the retirement given to the applicant w.e.f. 31<sup>st</sup> May, 2021 by the respondent No. 2 be quashed and set aside. Consequently, the respondents, particularly, the respondent No. 2 be directed to consider the correct date of birth of applicant as 14<sup>th</sup> October, 1966 and he be allowed to resume duty on his original post and for that purpose necessary directions be issued.”

3. It is the case of the applicant that his correct date of birth is 14.10.1966. However, in the service record it was mentioned as 1.6.1963. Learned counsel for the applicant submitted that the applicant got corrected his date of birth by filing appropriate application before the JMFC Court at Newasa bearing Criminal M.A. No. 134/2021 and

the learned Magistrate has passed the order dated 25.6.2021 thereby directing correction of date of birth of the applicant in the Grampanchayat record. Learned counsel submitted that after the said decision the applicant on 7.7.2021 made a representation to the District Superintendent of Police, Ahmednagar for carrying out the correction in his date of birth and to continue him in service till he attains the age of retirement on the basis of his corrected date of birth i.e. 14.10.1966 by withdrawing the order of superannuation. Learned counsel submitted that respondent No. 2 since has failed to consider the request of the applicant, the applicant is constrained to approach this Tribunal. Learned counsel in the circumstances, prayed for allowing the application.

4. Learned Presenting Officer has opposed the contentions raised by the applicant. Learned P.O. pointed out that during the entire service period the applicant did not file any application for his correction of date of birth. Learned P.O. pointed out that the applicant retired on 31.5.2021 after attaining the age of superannuation. Learned P.O.

further submitted that at that time also the applicant did not raise any objection and has filed representation two months' thereafter. Learned P.O. submitted that in the circumstances, no case is made out by the applicant for considering his request.

5. I have considered the submissions advanced on behalf of the applicant and the respondents. It is not in dispute that during the entire service period the applicant did not file any application seeking correction in his date of birth. The applicant entered into the Government service some times in the year 1991 and retired in the year 2021 i.e. after putting in service for about 30 years. The order passed by the J.M.F.C. Court on 25.6.2021 on the basis of which the applicant has made a representation for correction in the date of birth is in respect of the correction of date of birth in Gram Panchayat record. Insofar as service record is concerned, the applicant did never make any request during the service period. In the circumstances, I see no merit in the present Original
