Heard Shri S.S.Dambe, learned Counsel and Shri Sachin S. Deshmukh, learned Counsel holding for Shri Shaikh Majit S., learned Counsel for the applicants in respective O.As. and Shri M.S.Mahajan, learned Chief Presenting Officer for respondent authorities.

- 2. In both these O.As. as the grievances raised by the applicants and prayers made by them are identical, we have heard these matters together.
- Applicants have applied for the post of Junior 3. Engineer (Civil) Group-B (Non-Gazetted) pursuance of Advertisement No.1/2023 issued by the State Government on 10-10-2023. For the aforesaid post qualification prescribed the advertisement is 3 years diploma in Civil Engineering approved by the State Government or

The qualification equivalent thereto. any appointments on the aforesaid posts are governed by "Junior Engineer (Civil) Group 'B' non-gazetted in the Public Works Department and the Irrigation Department (Recruitment) Rules, 1998" notified on 01-01-1998. In the said Rules the requisite qualification prescribed for the post of Junior Engineer is 3 years diploma in Civil Engineering recognized by the Government or anv qualification recognized as equivalent thereto.

4. Learned Counsel appearing for the applicants pointed out that the total sanctioned strength of Junior Engineers (Civil), 75% are exclusively reserved for being filled up by nomination from amongst the candidates holding diploma. Learned Counsel further pointed out that after recruitment commenced by publication process was Advertisement No.01/2023 on 10-10-2023, on 26-10-2023 the State Government has notified the amended Rules thereby permitting the degree holders also to compete for the posts reserved for the diploma holders.

- 5. Learned Counsel for the applicants referred to two judgments, one of the Hon'ble Apex Court in the case of P.M.Latha & Others V/s. State of Kerala & Others reported in [(2003) 3 SCC 541] and other of the Hon'ble Uttarakhand High Court in the case of Vikas Kumar & Others V/s. State of Uttarakhand & Others [W.P.Nos.643/2015 with connected W.Ps.]. Learned Counsel pointed out that in view of the law laid down in the aforesaid judgments criteria of educational qualification cannot be changed after the advertisement inviting applications for the recruitment of any post is published. Learned Counsel submitted that if the degree holders are also permitted to apply for the subject posts along with diploma holders, it would be a competition between two unequals, which is apparently in violation of Articles 14 and 16 of the Constitution of India.
- 6. Learned Counsel submitted that according to the advertisement published on 10-10-2023, last date for submitting applications was 06-11-2023. Learned Counsel further submitted that in view of the amendment brought in the rules by the State Government

and the addendum published by the respondents on 27-10-2023 several candidates holding degree in Civil Engineering have applied for the subject posts. Learned Counsel submitted that if the respondents are permitted to proceed with the recruitment process irreparable loss would be caused to the applicants. Learned Counsel in present circumstances have for staying prayed implementation of the notification dated 26-10-2023 so far as clause 3(b)(2) thereof and the addendum dated 27-10-2023 are concerned.

- 7. Learned CPO seeks time to file the affidavit in reply. He contends that since the date for submitting the applications has expired, on the basis of amendment carried out in the Rules, several graduate candidates must have filed applications pursuant to the advertisement. Learned CPO submitted that, in the circumstances at this juncture no such interim relief as has been prayed for by the applicants can be granted.
- 8. In view of the fact that the date for submission of applications has already expired and the date of written examination is not yet declared, it would be

just and proper to give time to the respondents to submit the affidavit in reply. We, therefore, deem it appropriate to list the matter on 29-11-2023 for filing affidavit in reply by the respondents. It is clarified that, in the meanwhile if the date of examination is declared, it would be open for the applicants to move the matter before the Tribunal even in the vacation, if they so desire. We further wish to clarify that, if the recruitment process is carried forward, it shall be subject to outcome of the present two O.As.

- 9. Since learned CPO has caused appearance in the matter, no separate notice is again required to be issued to the respondents. Applicants shall provide the copies of paper book of O.A. along with all annexures to the respondents.

- 2. It is the grievance of the applicant that after about 16 years of the occurrence of the alleged incidence, respondents are subjecting him to undergo an enquiry. The applicant had retired on 31-10-2022 on attaining the age of superannuation. The incidence on the basis of which departmental proceedings are likely to be initiated, earlier a criminal prosecution was initiated against the applicant and the applicant has been acquitted from the said criminal case on 12-10-2018.
- 3. Learned Counsel submitted that after filing of the present O.A., the statement of charge has been served upon the applicant. Learned Counsel has sought leave to place on record those documents. Leave granted. It is further clarified that the

applicant will have to incorporate all those pleadings in his O.A. by making out a proper application seeking amendment.

- 4. In the circumstances learned Counsel has prayed for interim relief thereby directing the respondents not to proceed with the letter dated 24-03-2023 in furtherance of the enquiry against the applicant.
- 5. Learned P.O. submits that serious charges of causing financial losses to the Government are against the applicant and the losses are stated to be of Rs.34,39,295/-. Learned P.O. submitted that the respondents will file their affidavit in reply within 4 weeks from the date of this order. It is further contended that the Enquiry Officer has not yet been appointed in the present matter and as such for commencing enquiry proceedings in the real sense much time will be required. In the circumstances, learned P.O. has prayed for deferring the hearing even on the point of interim relief till filing of the reply by the respondents.

- 6. Delay on the part of the respondents is the eminent reason for causing interference in such type of the matters. Though it has been now said that huge losses are caused by the applicant to the Government, there is no answer as to why the enquiry proceedings were not initiated for long 16 years. Mere pendency of criminal case cannot be a ground for not initiating departmental proceedings against an employee. However, all these aspects are to be decided on merits.
- 7. In view of the submission made by the learned P.O. that the enquiry is not likely to be commenced in coming few days and before that the respondents are ready to file their affidavit in reply, and also ready to contest the matter on merit, following order is passed:

ORDER

- [i] Time is granted to the respondents for filing affidavit in reply till 01-12-2023.
- [ii] The prayer of interim relief is kept open and if reply is not filed on the next date, request for interim relief will be considered without reply of the respondents.
