JUDGMENT

1. The present Original Application has been filed by the applicant for the following reliefs :-

C. By issuing appropriate order or direction the respondent authorities may kindly be directed to grant promotion/pay scale to the applicant to the post of Police Sub Inspector with further directions to take appropriate entries in the service book and release all the monetary benefits towards from the date when the applicant was eligible to get the said promotion.

2. The facts on record would show that though the present applicant was selected in the list of probable employees picked for promotion, unfortunately the proposal dtd. 23.2.2015 sent by the lower authority to the State of Maharashtra remained pending before the State of Maharashtra for a period of more than three years (Annex. A. 5 page 17). In the meantime the present applicant is now superannuated and in view of his superannuation, the next of the employees are promoted. The fact regarding superannuation of the present applicant is revealed at the time of making submissions by the learned Advocate for the applicant. Unfortunately, therefore, the applicant cannot be granted any relief due to delay caused by the

res. no. 1 in accepting the proposal regarding promotion sent by the lower authority.

3. In the circumstances, the present Original Application is dismissed without any order as to costs.
