2. When the present application is taken up for consideration the learned Presenting Officer has again sought time for filing affidavit in reply in the O.A. It is submitted that the draft of the affidavit reply has already been forwarded to the authorities, but the same has not yet received approval.

3. Today, the learned Counsel for the applicant has tendered across the bar Misc. Application St. no. 273/2022 for considering the prayers made therein. The applicant intends to pursue the M.Sc. (Nursing) course and has applied for study leave with his department i.e. the respondent no. 2. It is further contended that as per the procedure, after grant of study leave, the application is routed through the

Department and is forwarded to the Nursing College, where the applicant intends to take admission for M.Sc. (Nursing). In the Original Application the applicant has impleaded the Institute of Nursing at Mumbai as the party respondent no. 3, since at the relevant time the applicant was desiring to take admission in the said Institute. In the present Misc. Application, the applicant has contended that time limit for submitting applications in the Institute of Nursing at Mumbai has expired and entire admission process is almost over. In the circumstances, the applicant has sought permission to add the College of Nursing, Government Medical College, Nagpur as the respondent no. 3-A, since admission process is still going on in the said College. The applicant is permitted to add 'College of Nursing, Government Medical College, Nagpur' as respondent no. 3-A in the Original Application. The applicant to carry out said amendment forthwith.

4. The learned Counsel for the applicant has further contended that today is the last date for submitting applications in the College of Nursing, Government Medical College, Nagpur, for M.Sc. (Nursing).

As further submitted the applicant is hopeful of getting admission in the said College at Nagpur.

5. In the present matter on 3.12.2021 following order was passed by the Tribunal :-

*“2. Respondent no. 4 though duly served has not posed his appearance in the matter. The present matter, therefore, shall proceed ahead ex-parte against the respondent no. 4.*

*3. When the matter is taken up for consideration the learned C.P.O. for the respondents has sought one week’s time for filing affidavit in reply of the respondents.*

*4. Learned Advocate for the applicant invited my attention to the order dated 9.11.2021 passed by this Tribunal and more particularly para 12 thereof. He further submitted that despite the specific directions given by this Tribunal to decide the representations submitted by the present applicant within the period of 2 weeks from the date of that order, the said representations have not yet been decided by the concerned respondents.*

*5. In view of above submissions made by both the sides, following order is passed :-*

**ORDER**

*(i) The respondent nos. 1 & 2 shall decide the representations submitted by the applicant as are mentioned in para 12 of the order passed by the Tribunal on 9.11.2021, on or before 10.12.2021.*

*(ii) If the respondent nos. 1 & 2 fail to decide the said representations on or before 10.12.2021, the said representations shall be deemed to have been accepted by the said authorities.*

*(iii) S.O. to 15.12.2021 for filing affidavit in reply by the respondents.*

*(iv) Steno copy allowed for the use of learned C.P.O. for the respondents.”*

6. In view of the aforesaid order, the respondent Nos. 1 & 2 were under obligation to take some decision on the representations made by the applicant. Today it is brought to our notice that no decision was taken by the said authorities within the stipulated period. The learned Counsel for the applicant further brought to our notice that vide communication dated 13.1.2022 the applicant has been informed that his request for study leave has been rejected on the ground that permission cannot be granted for pursuing M.Sc. (Nursing) course from private Institutions. The second ground as has been assigned for refusing the study leave to the applicant is that, in the Department excess number of trained Nurses are available, who may be eligible for promotion and therefore a decision has been taken not to permit any more candidate to pursue the said course in Private Institution.



7. The learned Counsel for the applicant submitted that, since, the representations of the applicant were not decided by the respondent nos. 1 & 2 within the given time as observed by this Tribunal in the order dated 3.12.2021, the said representations must be deemed to have been accepted by respondent nos. 1 and 2. He further submitted that since there were less chances of getting admission at Mumbai College, the applicant has taken admission in Mahatma Gandhi Mission's Mother Teresa College of Nursing, Aurangabad. The learned Counsel further submitted that the M.Sc. Nursing Course in Mahatma Gandhi Mission's Mother Teresa College of Nursing, Aurangabad is commencing from 28.2.2022. The applicant apprehends that, if the respondent nos. 1 & 2 do not relieve him for joining the P.G. course, he will be losing the chance of completing the P.G. course from the said College also. In the circumstances, interim relief has been sought for directing the respondent nos. 1 & 2 to relieve the applicant so as to enable him to join the M.Sc. Nursing course in Mahatma Gandhi Mission's Mother Teresa College of Nursing, Aurangabad in time.

8. The learned Counsel further submitted that in the communication dated 13.1.2022 nothing has been mentioned as to why permission has not been granted to the applicant, when he was seeking permission to take admission in Government Nursing College and not in a private Institution. The learned Counsel submitted that desperately the alternative prayer is made by the applicant for grant of permission for taking admission in Private College, though the applicant was aspiring for admission in Government College.

9. The learned Presenting Officer opposed for granting any interim relief as prayed by the applicant. He submitted that the applicant is not eligible for any study leave since he has not completed five years of service. He further submitted that the applicant himself has moved an application for regularization of his service and the same is pending. It is further argued that vide letter dated 13.1.2022 the applicant has been informed the reasons for which his applications seeking study leave has been rejected. The learned Presenting Officer on the aforesaid grounds prayed for rejecting the application and again

sought time for submitting affidavit in reply to the Original Application as well as to the present Misc. Application.

10. Shri Dharurkar, learned Counsel for the applicant bitterly criticized the approach and attitude of the respondents. He submitted that in the year 2013, the Division Bench of the Hon'ble Bombay High Court in the case of **Vishwajit Panchakshari Mathpati and Ors. Vs. State of Maharashtra and Ors., AIR 2013 (NOC) (SUPP) 380 (BOM.)** has ruled that once the Indian Nursing Council has prescribed the norms of eligibility, it was not open for State Government to prescribe conditions at variance with those prescribed by the authority acting under the Central legislation enacted with reference to Entry 66 of the Union List. The eligibility criteria for admission to P.G. course of M.Sc. Nursing by Indian Nursing Council stipulates minimum one year experience prior to or after the B.Sc. degree. We deem it appropriate to reproduce para 4 of the said judgment, which reads thus :-

*“4. The Indian Nursing Council Act, 1947 is relatable to the power conferred upon Parliament by Entry 66 of the Union List to the Seventh Schedule. In State of Tamil Nadu & Anr. vs.*

*Adhiyaman Educational & Research Institute & Ors. ((1995) 4 SCC 104 ) the Supreme Court has held that it is not open to the authorities under the State Government to prescribe norms at variance with what is prescribed by the AICTE constituted under the All India Council for Technical Education Act, 1987. Even a more stringent norm cannot be prescribed. In the present case, once the Indian Nursing Council has prescribed the norms of eligibility for admission to the M.Sc. (Nursing) Course, it was not open to the State Government to prescribe conditions at variance with those prescribed by the authority acting under the central legislation enacted with reference to Entry 66 of the Union List. In the circumstances, the ground which has been advanced on behalf of the State Government for declining to relieve the Petitioners is contrary to law. We accordingly set aside the communication dated 30 October 2012 (Exhibit "H").*

11. In view of the law laid down as above, the contentions raised by the learned P.O. that the applicant is not possessing the experience of 5 years of service is liable to be rejected at the threshold. The another ground which has been assigned for not accepting the request of the applicant is that the applicant cannot be permitted to complete M.Sc. Nursing course from any private Nursing College.

12. In the order passed by this Tribunal in O.A. No. 21/2019 on 15.2.2019, the authorities of Health

Services Directorate were directed to go through the Circular dated 3.5.2018 of Medical Education & Drugs Department and to take corrective steps. Vide the said Circular the Department of Medical Education & Drugs has resolved to grant study leave for completing the P.G. course even through the private Colleges of Nursing. It seems that the said directions have been completely ignored by the respondents and have refused to grant study leave to the present applicant on the ground that no such permission can be granted to complete the P.G. course from any private College of Nursing.

13. After having considered the facts as above and the law laid down in the case of **Vishwajit Panchakshari Mathpati and Ors.** (cited supra) as well as the directions given by this Tribunal in the order dated 15.2.2019 passed in O.A. No. 21/2019, we are convinced that there exists a prima-facie case in favour of the applicant. Even at the present posting the applicant has been serving for more than two years, whereas the experience of only one year is prescribed by Indian Nursing Council. Further, prima-facie, there seems no rational in refusing the

study leave on the ground that the post-graduation is being done in a Private College, considering the directions given by this Tribunal in O.A. No. 21/2019. There are excess number of Nurses holding the higher qualification also cannot be ground for refusing permission to the applicant or any other desiring candidate. Having regard to the approach adopted by the respondents till date, the apprehension in the mind of the applicant cannot be said to be misplaced. If the respondents do not relieve the applicant before 28<sup>th</sup> February, 2022, the applicant may not be able to join the course. Balance of convenience, thus, lies in favour of the applicant. No prejudice is likely to be caused to the respondents if the applicant pursues the post-graduation from a private College. We are, therefore, inclined to accept the prayer for interim relief. Hence, the following order :-

### **ORDER**

1. Issue notice to the added respondents in the present M.A, returnable on 23.2.2022.

The copy of present M.A. is supplied to the learned P.O. on instructions of the Tribunal.

2. Tribunal may take the case for final disposal at once and separate notice for final disposal shall not be issued.

3. Applicant is authorized and directed to serve on respondent/s intimation/notice of date of hearing duly authenticated by Registry, along with complete paper book of the case. Respondents are put to notice that the case would be taken up for final disposal at the stage of admission hearing.

4. This intimation/notice is ordered under Rule 11 of the Maharashtra Administrative Tribunal (Procedure) Rules, 1988, and the questions such as limitation and alternate remedy are kept open.

5. The service may be done by hand delivery, speed post, courier and acknowledgment be obtained and produced along with affidavit of compliance in the Registry before due date. Applicant is directed to file affidavit of compliance and notice.

6. The respondent nos. 1 & 2 are directed to relieve the applicant for pursuing the P.G. course of M.Sc. Nursing at Mahatma Gandhi Mission's Mother Teresa College of Nursing, Aurangabad before 26<sup>th</sup> February, 2022.

7. It is clarified that all interim orders passed in the present matter are subject to final outcome of the Original Application.
