2. Learned Advocate for the Applicant has submitted that the Applicant was deputed at Civil Hospital Osmanabad by order dated 20.6.2016 for completion of post graduation course CPS (DGO). Learned Advocate for the Applicant has submitted that the Applicant has not completed the P.G. course in 1st attempt and therefore, he has been posted as Medical Officer, Sub District Hospital, Kalamnuri, District Hingoli by order dated 6.3.2019. Thereafter, in the general transfer of year 2019, the Applicant has been transferred at Rural Hospital Manwat, District Parbhani in view of the Section 4(4) and 4(5) of the Transfer Act, 2005 by order dated 28.05.2019.

3. Learned Advocate for the Applicant has further submitted that thereafter the Respondents issued impugned order dated 29.8.2019 and posted him at Shriwardhan as Medical Officer in the Sub District Raigad on completion of his P.G. Course.

He has submitted that the impugned order is in contravention of the Transfer Act, 2005 and it has been made before completion of the normal tenure of the Applicant at Manwat. He has submitted that the Applicant was working as Medical Officer at Rural Hostial Manwat, District Parbhani and without any sufficient reason he has been transferred at Shriwardhan and the distance between Manwat to Shriwardhan is 400 k.m. He has submitted that nobody has been posted on the place of the Applicant and Applicant is still working there. Therefore, he has prayed to grant interim relief.

4. Learned P.O. for the Respondents has submitted that as per the terms and conditions order of deputation, the Applicant has to inform the Director, Health services regarding passing of P.G. course. He has submitted that the Applicant had not informed regarding passing of P.G. course accordingly at the time of general transfer of year 2019. Thereafter he informed his higher authority about his passing of P.G. Course. After completion of P.G. course he has been posted on the post earmarked for P.G. medical officer. There is no illegality in the impugned order. Therefore, he has prayed to reject the interim relief.

5. On perusal of record, prima facie it reveals that the conditions mentioned in the order dated 20.06.2016, while sending the Applicant on deputation for P.G. course, it has been mentioned that he has to inform the Director of Health Service regarding passing

of his P.G. Course. Earlier the Applicant failed to pass the P.G. course in 1st attempt and therefore he has been transferred and posted as Medical Officer at Manwat. After passing the P.G. course, the Applicant has been posted as Medical Officer on earmarked post for P.G. Medical Officer at Shriwardhan.

6. Prima-facie there is not illegality in the impugned order. There no just ground to grant interim relief. In view of this, in my view, it is not a fit case to grant interim relief. Hence request to grant interim relief is rejected.

7. Issue notices to the Respondents returnable on 9.10.2019.

8. Tribunal may take the case for final disposal at once and separate notice for final disposal shall not be issued.

9. Applicant is authorized and directed to serve on respondent/s intimation/notice of date of hearing duly authenticated by Registry, along with complete paper book of the case. Respondents are put to notice that the case would be taken up for final disposal at the stage of admission hearing.

10. This intimation/notice is ordered under Rule 11 of the Maharashtra Administrative Tribunal (Procedure) Rules, 1988, and the questions such as limitation and alternate remedy are kept open.

11. The service may be done by hand delivery, speed post, courier and acknowledgment be obtained and produced along with affidavit of compliance in the Registry before due date. Applicant is directed to file affidavit of compliance and notice.

12. If notice is not collected within 7 days or proof of service is not produced before 3 days of the next date, case shall automatically stand dismissed without further reference to the Tribunal.
