- (D) Any other suitable and equitable relief to which the applicants are entitled to, may kindly be granted in their favour.”*

3. Learned Advocate for the applicant seeks liberty to amend the present Original Application for challenging the impugned order 06.02.2023 (Annexure A-3) to the extent of deletion of names of applicants for calling upon them for documents verification on 8<sup>th</sup> and 9<sup>th</sup> February, 2023. Further he seeks amendment in the O.A. to place reliance on Government Circular dated 19.07.2001 dealing with new appointment to the post of Group-D (Class-IV) post from amongst eligible Kotwals and G.R. dated 17.12.2021 dealing with relaxation to the candidates who are age barred during the period of 01.03.2020 till issuance of the G.R. dated 17.12.2021.

4. Liberty as prayed for by the applicants is granted to raise the pleadings by amending the Original Application in that regard. The applicant shall carry out the necessary amendment in the O.A. within a period of three days and to serve the amended copy of the O.A. on the other side.

5. The applicants claim that they are eligible for being considered for the post of Group-D (class-IV) in view of the G.R. dated 07.05.1959. The applicants are working as Kotwal since 2007-09. The respondents prepared the list of eligible candidates from Kotwals cadre for appointment to the post of Group-D (Class-IV) as per the

communication dated 02.06.2022 (Annexure A-2). As per the said list, the names of the applicants were included in the said list of Kotwals, who are eligible for appointment in Group-D (Class-IV) category. However, subsequently by the impugned letter dated 06.02.2023 (Annexure A-3), names of the applicants were deleted and rest of the candidates from the above-said list annexed with letter dated 02.06.2022 (Annexure A-2) were only called for production of documents and for considering them further for appointment.

6. Learned Advocate for the applicants submitted that the respondents have illegally deleted the names of the applicants from the eligible candidates on the ground that they are age barred, but only referring to the Government Circular dated 19.07.2001. In view of the same, he submitted that this is a fit case for grant of interim relief, as the candidates have been called for documents verification on 8<sup>th</sup> and 9<sup>th</sup> February, 2023.

7. Learned C.P.O. opposed the submissions advanced on behalf of the applicant and submitted that in terms of Government Circular dated 19.07.2001, the applicants have crossed the age limit of 45 years, which is provided as per the said G.R. dated 19.07.2001. Therefore, the names of the applicants were rightly deleted from the above-said list.

8. After having considered the pleadings on record and submissions advanced on behalf of both the sides, we are of the opinion that the relevant G.R. dated 19.07.2001 specifies the upper age limit of 45 years for consideration of Kotwals for new appointment to the post of Group-D (Class-IV) Government servant. In view of that it would be just and proper to refer to the G.R. dated 17.12.2021, issued by the General Administration Department, State of Maharashtra for giving relaxation to those candidates, who have become age barred during the period of 01.03.2020 till the date of issuance of G.R. dated 17.12.2021 for the recruitment up to 31.12.2022.

9. Learned C.P.O. submitted that this G.R. dated 17.12.2021 is applicable only to the new appointments through nomination and not to the promotional post. For that purpose he invited our attention to the impugned letter dated 06.02.2023 (Annexure A-3), whereby it is mentioned that this is a process of absorption by promotion and also relied upon the G.R. dated 06.02.2019, whereby it is mentioned that the post of Group-D cadre from amongst Kotwals is promotional post. However in terms of Clause (3) thereof the appointment to the post of Group-D cadre amongst Kotwal is referred as new appointment to the post of Group-D without extending the benefits of past services.

10. In view of the same, in our considered opinion, prima-facie, it appears that this is a recruitment i.e. new appointment by nomination only. Hence, in our considered opinion, the eligible applicants are entitled to claim benefit of age relaxation as per the G.R. dated 17.12.2021.

11. Upon perusal of the facts, we find that the applicants, who are age barred during the period of 01.03.2020 till issuance of the G.R. dated 17.12.2021 only will be eligible and entitled for participation into further process of recruitment of Group-D category posts. In view the same, interim relief is granted to the extent of directing the respondents to identify the applicants in this Original Application, who have age barred during the period from 01.03.2020 to 17.12.2021 and allow them in the selection process of Group-D cadre post as per the impugned letter dated 06.02.2023 (Annexure A-3) by specifying any suitable date on or before 15.02.2023. This relief is granted subject to

It is the grievance of the applicant that more than two years after her retirement now the respondents have directed recovery of huge amount of Rs. 20,93,900/- by the impugned order dated 19.1.2023 on account of excess payment made to her during the period from 1992 till her retirement. Learned counsel submits that recovery so directed is impermissible in view of the law laid down by the Hon'ble Apex Court in the case of **State of Punjab and others Vs. Rafiq Masih (White Washer) etc., AIR 2015 SC 596**. In the circumstances, learned counsel has prayed for staying the effect and operation of the impugned order dated 19.1.2023 until final disposal of the present O.A.

3. Learned counsel further submits that the applicant has not yet been sanctioned provisional pension also on the aforesaid ground.



4. Learned Presenting Officer has sought time to seek instructions and to file affidavit in reply.

5. After having considered the facts and circumstances of the present case, it appears to me that *prima facie* case is certainly made out by the applicant for grant of interim relief as has been prayed for by her. The applicant is stated to be class-III employee and has retired in the year 2020. The recovery which has been sought is on account of excess payment made to the applicant in the period starting from the year 1992 till the date of her retirement. In the circumstances, stay deserves to be granted for execution and operation of the impugned order until further order. Hence, the following order: -
