The applicant has filed the present O.A. for his reinstatement in service in pursuance of the order passed by the Hon'ble High Court of Judicature at Bombay, Bench at Aurangabad on 23.9.2019 in writ petition No. 7510/2019 and also prayed to direct the respondents to pay his salary from 3.4.2019.
- 3. Learned Advocate for the applicant submitted that in spite of quashing of the order of suspension by the Hon'ble High Court, the respondents are not allowing the applicant to join the duties and they are not paying the salary to the applicant and therefore the applicant has approached He has submitted that by way of this Tribunal. interim directions the respondents be directed to pay salary to the applicant from 3.4.2019.

- 4. Learned Presenting Officer has submitted that the respondents have not filed their affidavit in reply and he therefore sought time to file affidavit in reply on the ground that in the present situation the answering respondents are not available in the office because of spread of COVID-19 / Corona virus. He has submitted that the matter can be decided on merit after filing detailed affidavit in reply by the respondents. He has further submitted that since the applicant has not been permitted to join the duty he is not entitled to get salary.
- 5. On perusal of record it reveals that the suspension order has been quashed by the Hon'ble High Court in writ petition no. 7510/2019 on 23.9.2019. On perusal of the prayer G(iii) of the O.A. it reveals that the applicant is seeking execution and operation of the order dtd. 23.9.2019 passed by the Hon'ble High Court passed in writ petition no. 7510/2019 from this Tribunal by filing the O.A. The said relief cannot be granted by the Tribunal. The applicant has to join the service in pursuance of the order of Hon'ble High Court dtd. 23.9.2019 passed in writ petition no. 7510/2019 first for claiming the

salary. Without considering the affidavit in reply of the respondents the present O.A. cannot be disposed of on merit. Hence the prayer of the applicant for grant of interim relief cannot be considered at this stage.

- 6. Therefore, the prayer of the applicant for grant of interim relief is rejected.
- 7. In these circumstances, S.O. to 7.7.2020 for filing detailed affidavit in reply by the respondents as a most last chance.
