2. Today when the present matter is taken up for consideration, learned Presenting Officer again sought time to file affidavit in reply on behalf of respondents. Request is strongly opposed by the learned counsel appearing for the applicant. Record also shows that due opportunities are already availed by the respondents. Learned P.O. submitted that though the concerned office was communicated, there is no response from the officer concerned. As such, I am not inclined to grant further time.

3. It is the case of the applicant that since last year he is requesting for his transfer at Aurangabad on the ground that his wife is posted as Associate Professor in the Government Medical College and

Hospital, Aurangabad. It is the case of the applicant that he has already completed his ordinary tenure at Basmat, Dist. Hingoli. Learned counsel pointed out that the applicant has made a detailed representation on 05.06.2023. However, his request has not been considered by the authorities concerned. Learned counsel submitted that there are vacancies at Aurangabad.

4. As contended in the Original Application, the applicant is working as Medical Officer at Basmat, Dist. Hingoli since 17.01.2019. The wife of the applicant is also in the Government service. On promotion, she has been promoted on the post of Associate Professor in the Government Medical College and Hospital, Aurangabad. There are guidelines and it is policy of the Government to consider the request of the Government employees for their transfers under the principle of couple convenience. In the present Original Application, the only request of the applicant is that the respondents shall positively consider his request. The applicant has sent a detailed representation on 05.06.2023. The same has not yet been decided by

the authorities concerned. As has been submitted by the learned counsel for the applicant there are vacancies at Aurangabad. In the circumstances, the present Original Application can be disposed of by giving certain directions. Hence, the following order:-

**ORDER**

- (i) The respondents are directed to consider the request of the applicant made by him vide his representation dated 05.06.2023 within a period of 4 weeks from the date of this order and communicate the decision thereof to the applicant.
- (ii) Accordingly, the Original Application stands disposed without any order as to costs.

2. It is the case of the applicant that his name was included in the merit list for the post of Deputy Education Officer, the recruitment of which was initiated pursuant to the advertisement dated 08.02.2008, but was not given appointment since some litigation pertaining to reservation for SBC category to which the applicant belongs was pending. The candidate, who was below the applicant in the merit list, was given appointment. After the decision in the pending litigation, the applicant came to be appointed on 04.03.2014.

3. It is the grievance of the applicant that while preparing the seniority list for the cadre of Deputy Education Officers, the respondents have not

applied the principle of deemed date, which has resulted in showing the name of the applicant below the candidates, who were junior to him in the merit list on the basis of which the appointments were made.

4. Learned counsel appearing for the applicant referring to sub-rule (2) of Rule 5 of the Maharashtra Civil Services (Regulation of Seniority) Rules, 1982 submitted that while preparing list of seniority, the respondents must have placed the applicant above the candidates, who were below him in the merit list on the basis of which the appointments were issued irrespective of the fact that the candidates junior in the said list were appointed prior to the applicant. Learned counsel submitted that because of pending litigation though the applicant was at higher place in the merit list was not given appointment and the persons junior to him were offered appointments. In the circumstances, according to the learned counsel, having regard to Rule 5(2) of the Regulation of Seniority Rules, 1982, the applicant shall be deemed to have appointed on the date on which the

candidate junior to him in the merit list was appointed. Learned counsel further submitted that the process for promotion to the post of Education Officer is presently in progress. He further submitted that the applicant is aspiring for the said promotion. He further submitted that because of an incorrect seniority list prepared and finalized by the respondents, name of the applicant has been wrongly shown below the candidates who were junior to him in the merit list from out of which the appointments were issued. In the present Original Application, the applicant has challenged the said seniority list published on 01.08.2023. Learned counsel while praying for issuance of notice to the respondents in the present matter, also prayed for interim relief seeking direction against the respondents not to proceed with the promotions to the post of Education Officer till final decision of the present Original Application. Learned counsel submitted that if the deemed date is awarded to the applicant, he will move at the higher place in the list of seniority and is sure about his promotion to the post of Education Officer. Learned counsel submitted that if the process for promotion is not

restricted, the applicant would lose his chance to be selected to the post of Education Officer. He therefore, prayed for interim relief as has been prayed in the present Original Application.

5. Learned Presenting Officer has sought time to file affidavit in reply after taking instructions from the respondents. Learned P.O. however, submitted that even if it is assumed that some case is there in favour of the applicant, it may not be proper to stay the entire process of promotion. Learned P.O. has therefore, prayed for rejecting request of interim relief and to decide the issue finally.

6. After having considered the submissions made on behalf of the applicant, as well as, respondents and on going through the documents filed on record it appears that the applicant has made out a prima-facie case in his favour. The documents apparently show that the candidates who were shown below the applicant in the merit list were appointed on earlier date and delay occurred in issuance of appointment in favour of the applicant because of pending litigation, for which no blame can be

attributed on part of the applicant. Prima-facie it appears that Rule 5(2) of the Regulation of Seniority Rules, 1982 favours the case of the applicant. However, I am not inclined to stay the entire process of promotion, which is in progress. The interest of the applicant can very well be protected by giving direction restricted to the case of the applicant. I therefore, deem it appropriate to pass the following order, which would serve the ends of justice :-

### **ORDER**

- (i) Issue notices to the respondents, returnable on 06.09.2023. **In the meanwhile, if the process for promotion to the post of Education Officer is carried forward by the respondents and if candidates who are shown in the final seniority list as on 01.01.2021 published on 17.04.2023 at Sr. No. 118 or below thereof are given promotions, their promotions shall be subject to outcome of the present Original Application.**
- (ii) Tribunal may take the case for final disposal at once and separate notice for final disposal shall not be issued.
- (iii) Applicant is authorized and directed to serve on respondent/s intimation/notice of date of hearing duly authenticated by Registry, along with complete paper book of the case. Respondents are put to notice that the case would be taken up for final disposal at the stage of admission hearing.
