4. On behalf of the applicant it is submitted that the applicant has not been relieved so far and no one has been transferred / posted on his post.

5. To challenge the order of transfer, the applicant has relied on the Judgment dated 17/1/2014 passed by the Hon'ble Bombay High Court, Bench at Nagpur in Writ Petition No.2770/2013. In this Judgment it is observed –

“ We therefore clarify the position accordingly and respondent no.2 to see that employees, who have put in more than three years of service in tribal/ naxalite areas, are transferred out of said areas as the employees who have put in three years service earlier in such areas, cannot be sent back to that areas.”

6. In view of facts of the case and ratio of the above referred Judgment, the case is made out to stay effect and implementation of the impugned order till the returnable date.

7. The effect and implementation of the impugned order shall stand stayed till the returnable date.

3. In reply, it is submitted by learned CPO that considering the pay scales of the applicants procedure of counselling and calling options could be dispensed with.

4. The Civil Services Board was duly constituted.

5. It is not made clear whether, before passing the impugned order procedure under Section 4 (2) of the Transfers Act, 2005 was followed. It is submitted by the learned CPO that on this point he will take instructions and make a statement on the returnable date.

“सदर बदल्यांमत्तं व्यक्क लोकहित व विद्यार्थीहीत हं एकमत्र कारण आहं उपरोक्त वस्तुस्थिती विचारांत घेतूं मं न्यायिकरणाय आदालासुसए परीच्छद क्र. ३ मदील नमूद अध्याकांनी त्यांची बदली करण्याबाबत काळ्यां विनंत्यां अमल्य करण्यांत आहं.”

7. On behalf of the applicants, for grant of interim relief, reliance is placed on the order dated 4/7/2023 passed by the Aurangabad Bench of this Tribunal in a batch of three O.As. Following interim order was passed by the Aurangabad Bench of this Tribunal –

“(1) Issue notices to the respondents, returnable on 25.7.2023, till then the respondents shall allow the applicants to perform their duties at their existing posts.”

8. It is submitted by learned CPO that before the Aurangabad Bench of this Tribunal the details which have been today placed before this Bench by communication dated 6/7/2023 were probably not placed.

9. The communication dated 6/7/2023 along with minutes of meeting held on 23/5/2023 shows that representations made by the applicants were considered and rejected.

10. The question is whether interim order like the one passed by the Aurangabad Bench of this Tribunal should be passed in this batch of O.As. It would be advisable to defer the question of grant of interim order till the next date. The CPO shall make a statement whether or not procedure under Section 4 (2) of the Transfers Act, 2005 was followed.
