- 3. However, disciplinary authority has shown disagreement and vide order dated 24.12.2016 (Annexure-A-7, P.B., Pg. No. 25) has awarded punishment and stopped one increment with

permanent effect and treat suspension period as suspension.

4. Applicant appealed to respondent no. 2 vide his letter dated 16.04.2016 (Annexure-A-8, Pg. Nos. 27 to 30) to Commissioner, Tribal Development, Nashik against this order.
