As per submission of the learned counsel for the applicant, the applicant was having a regular charge of Chief Officer, Municipal Council Bhadravati On 08.09.2022 at about 05.00 pm. letter was issued by Tahsildar, Chandrapur directing him to disburse the cheque amount to the affected person. Cabinet Minister visited Ghuggus on 08.09.2022 itself the applicant was not knowing about the programme of Cabinet Minister therefore he was not present.

3. The respondent no.1 issued suspension order on 15.09.2022 suspending the applicant about the dereliction of his duty because he was not present at Ghuggus and Cabinet Minister was waiting for about three hours for the arrival of the applicant. As per submission of the learned counsel for the applicant, the applicant was not knowing about the programme of Cabinet Minister. He was informed only to disburse the cheque by letter dated 08.09.2022. It was not received by the applicant on 08.09.2022 because the same letter was issued at about 05.00 pm. Therefore, the Chief Officer i.e. the applicant was not at fault. The applicant is wrongly suspended by the respondent no.1.

4. It appears from the letter issued by Tahsildar Chandrapur, dated 08.09.2022 that the applicant was informed to disburse the cheque amount to the land slide affected person at Ghugus except that directions there is nothing in the letter directing him to remain present in the programme of Cabinet Minister. No any show caused notice was issued before the suspension order. It appears that the applicant was not present in the programme of Cabinet Minister and therefore suspension order is issued.

5. The learned P.O. seeks time to get instructions.

6. From perusal of letter issued by Tahsildar, Chandrapur it is clear that the letter was issued on 08.09.2022. The applicant was directed to disburse the amount of Rs.16,00000/- to 160 family at Ghugus. There was no directions to the applicant to remain present in the programme of Cabinet Minister. The applicant was having regular charge of Chief Officer at Bhadravati. Therefore, he could not attained immediately in the programme of Cabinet Minister. Moreover there was no directions to the applicant to remain present. From the perusal of suspension order it appears that no any show caused notice was



issued to the applicant. The suspension order is issued only because he was not present in the programme of Cabinet Minister. Without any opportunity to the applicant the suspension order is passed on 15.09.2022. Hence, the order.

7. Interim relief is granted. The impugned suspension order dated 15.09.2022 is hereby stayed till 27.09.2022.
