2. As submitted by the Id. counsel for the applicant, applicant has appeared for appointment of P.S.I. examination to be conducted by M.P.S.C.. As per submission, applicant has passed the preliminary examination and also passed the main examination; after that when physical test was to be done, applicant was found Covid-19 positive and applicant informed to the respondents regarding the same. The grievances of the applicant is that subsequently he was not given chance for physical test as per letter dated 21.12.2020 (Annexure-A-16, P.B., Pg. No. 66).

3. If any result of the said examination is declared, it will be subject to the outcome of the original application, it should be made clear by respondents to the successful candidates.

4. Issue notice to Respondents, returnable on four weeks. Learned C.P.O. waives notice for R-1. Hamdast allowed.

5. Tribunal may take the case for final disposal at this stage and separate notice for final disposal shall not be issued.

6. Applicant is authorized and directed to serve on Respondents intimation / notice of date of hearing duly authenticated by Registry, along with complete paper book of O.A. Respondent is put to notice that the case would be taken up for final disposal at the stage of admission hearing.

7. This intimation / notice is ordered under Rule 11 of the Maharashtra Administrative Tribunal (Procedure) Rules,1988, and the questions such as limitation and alternate remedy are kept open.
