2. The applicant who is a person with 75% disability is relying on G.Rs. dated 15.04.2004 as well as 06.08.2002. He is also relying on the notification issued by G.A.D., State of Maharashtra by which Rules of Revenue Division allotment for appointment by nomination and promotion to the posts of Group-A and Group-B (Gazetted and Non-Gazetted) of the Government of Maharashtra Rules 2015 have been amended. The applicant is specifically relying on Clause-B of Rule 6. Latter part of said Clause-B reads as under:-

"For appointments to the posts by promotion, the Revenue Divisions shall be allotted to all officers in a select list at the same time except in cases which are kept open due to non-availability of confidential reports, non-availability of caste validity certificates and in which departmental enquiries are in progress or where the subject matter is *sub-judice*. In case of the latter, such allotment of Revenue Divisions shall be made separately after final decisions on them."

- 3. It is the contention of the applicant that considering aforementioned provisions he ought to have been posted at Bhandara. Promotion/ posting order dated 29.12.2021 (A-1) shows that at Bhandara one Shri Ajay Gopichand Dadmal has been posted on promotion. It is submitted by Id. C.P.O. that if the applicant is praying for posting on promotional post at Bhandara in place of Shri Ajay Gopichand Dadmal then said person would be a necessary party in whose absence interim order should not be passed. There is merit in this submission. The Id. counsel for the applicant states that he will add Shri Ajay Gopichand Dadmal as a party respondent. **On the returnable date the applicant would be at liberty to pray for grant of Interim Relief.**
- 4. Issue notice to Respondents, returnable on <u>one week</u>. Learned C.P.O. waives notice for R-1. Hamdast allowed.
- 5. Tribunal may take the case for final disposal at this stage and separate notice for final disposal shall not be issued.

6. Applicant is authorized and directed to serve on Respondents intimation /

notice of date of hearing duly authenticated by Registry, along with complete paper

book of O.A. Respondent is put to notice that the case would be taken up for final

disposal at the stage of admission hearing.

7. This intimation / notice is ordered under Rule 11 of the Maharashtra

Administrative Tribunal (Procedure) Rules, 1988, and the questions such as limitation

and alternate remedy are kept open.
