Thus it is shown that the applicant is surprised he was kept in dark and he was allowed to proceed under belief that he was not due for transfer and considering this fact, in my opinion this is a fit case to grant interim relief. The respondents are directed not to relieve the applicant from his posting Amravati till further orders.
