The applicant is relying on communication dated 22.07.2022 at page 15 of C.A. that shows that the person who was to join on the post previously held by the applicant had sought time to join on the post because of some personal difficulties.

5. It is submitted on behalf of the applicant that order of status quo as regards actual relieving of the applicant pursuant to order dated 15.07.2022 shall suffice. Accordingly status quo shall be maintained with regard to relieving of the applicant pursuant to order dated 15.07.2022.
