Heard Shri A.M. Borkar, Id. counsel for the applicant and Shri V.A. Kulkarni, Id. P.O. for the respondents.

2. The Id. P.O. has filed reply of R-4&5. It is taken on record and copy is given to the applicant.

3. As per submission of learned counsel for the applicant, the inquiry was started on 14/05/2018 as per letter dated 14/05/2018 (Annex-A-8, Page no.39) by the respondents. But till now the departmental inquiry has not been completed.

4. The learned counsel for the applicant has filed Govt. G.R. dated 7/4/2008. The para-2 and 3 of the G.R. are reproduced as below –

२) म.ना.से. (शिस्त व अपील) नियम, १९७९ च्या नियम ८ खालील विभागीय चौकशी प्रकरणे पूर्ण करण्याचा कालावधी हा चौकशी सुरु करण्याचा निर्णय झाल्यापासून जास्तीत जास्त सहा महिन्यापेक्षा अधिक नसावा.

३) तथापी काही प्रकरणांमध्ये उचित व पुरेशा कारणासाठी सहा महिन्याच्या विनिर्दिष्ट काळामध्ये विभागीय चौकशी पूर्ण करणे शक्य नसेल तर विभागीय चौकशी पूर्ण

करण्यासाठी असलेली ही कालमर्यादा वाढवून देण्याचे अधिकार विभागीय चौकशी नियम पुस्तिका १९९१ मधील परि. ३.१९ (परिशिष्ट-८) नुसार आहेत.

5. This seems to be as per the Judgment of **Hon'ble Apex Court in case of Prem Nath Bali Vs. Reg., High Court of Delhi & Anr. decided on 16 December, 2015** in Civil Appeal No. 958 of 2010. However, as per decision in the recent Larger Bench Judgment of Hon'ble Apex Court in the case of **State of M.P. and others Vs. Akhilesh Zha and others, 2022 (1) Mh.L.J.,557**, the period of minimum 9 months is to be given to complete the departmental inquiry.

6. In view of Judgment of Hon'ble Apex Court in the case of **State of M.P. and others Vs. Akhilesh Zha** (cited supra), the respondents are directed to complete the departmental inquiry of applicant within 9 months from the date of this order.

7. In view of above direction, the O.A. is disposed off. No order as to costs.
