2. The issue pertains to the common departmental enquiry, in which first order was passed in O.A. No. 699/2012 on 06/11/2018 and in this O.A. following order was passed:-

(i)The O.A. is partly allowed.

(ii)Suspension order of the applicant issued by respondent No.3 dated 16.5.2011 (Annexure A-1) and reference based letter dated 14.5.2011 issued by Collector, Nagpur(R.4)(Annexure A-2) are quashed and set aside after 90days of the date of passing said order.

(iii)It is hereby declared that the applicant shall be deemed to have been reinstated in service on completion of 90 days of suspension period for the date of order dated 16th May 2011.

(iv)The applicant will be entitled to claim all admissible dues, due to revocation of such suspension.

(v)The respondents are directed to take a decision on the applicant's request for advance taken from provident fund account vide letter dated 27.7.2011, within two months from the date of this order.

*(vi)Considering the fact that the applicant is under suspension from 16.5.2011 and a departmental enquiry has not yet been completed against the applicant, **the respondents are directed to complete the enquiry in all respects within a period of six months from the date of this order in any circumstances.***

(vii)If the respondents failed to complete the departmental enquiry within six months from the date of passing of this order, the departmental enquiry shall stand quashed without reference to the order of this Tribunal.

(viii)No order as to costs.

3. As per the above order in para no. VI last line clearly says :-

"the respondents are directed to complete the enquiry in all respects within a period of six months from the date of this order in any circumstances."

The order dated 06.11.2018 for six months expired on 06.05.2019.

4. Then in O.A. No. 971/2018 matter was heard on 13.03.2019 and on Pg. No. 32 in para no. 03 following orders has been passed:-

"3. It is important to note that the present applicant is one of the delinquent in the same enquiry, therefore, on the ground of parity, he is also entitled for the same relief. Therefore, we are of the view that the relief in terms of the final order, Clause nos. (VI) and (VII) be granted to the present applicant as per the final order in O.A. No. 699/2012."

5. This means that the departmental enquiry against applicant also should have been completed in all respect prior to 06.05.2019. However, the Id. Counsel for the applicant pointed out that no sufficient progress has been done by respondents to complete the departmental enquiry as per above both orders.

6. In view of Judgment in O.A.No.699/2012 dated 06.11.2018 and Order

in O.A.No.971/2018 dated 13.03.2019, respondents were bound to complete departmental enquiry in all respect on or before 06.05.2019. However, the Id. counsel for the applicant points out that nothing progress has been made in this regard.

By above G.Rs. Government policy is very clear that if an employee has work for atleast two years in Tribal or Naxal Area, he/she should be given posting as per his/her choice.

5. Apparently, the applicant has completed this provision of G.R. and applicant has served more than three years in Naxal and Tribal Area. Nothing adverse remarks appears on record about the applicant. However, in transfer order dated 31/05/2019 (Annexure-A-7), applicant is at Sr. No. 08 and posted to Kolhapur, which is contrary to her application on P.B., Pg. No. 19 were applicant has requested for posting at following three choices :-

1. Amravati(Dayapur, Achalpur)
