The Registrar, Central Administrative Tribunal, Madras Bench, High Court Complex, Chennai-600 105 delivered on 15/09/2017 at Annexure-A-4, P.B., Pg. No. 12.
- 6. In the same Judgment in para no. 5 following observations have been made:-

"The Petitioner retired as Additional Director General, Chennai on 30.06.2013 on attaining the age of Superannuation. After the Sixth Pay Commission, the Central Government fixed 1st July as the date of increment for all employees by amending Rule 10 of the Central Civil Services (Revised Pay) Rules, 2008. In view of the said amendment, the petitioner was denied the last increment, though he completed a full one year in service, i.e. from 01.07.2012 to 30.06.2013. Hence,

the petitioner filed the original application in O.A. No. 310/00917/2015 before the Central Administrative Tribunal, Madras Bench, and the same was rejected on the ground that an incumbent is only entitled to increment on 1st July if he continued in service on that day"

7. In the same Judgment in para no. 7 Hon'ble High Court has observed following points:-

"The petitioner herein had completed one full year service as on 30.06.2013, but the increment fell due on 01.07.2013, on which date he was not in service. In view of the above judgment of this Court, naturally he has to be treated as having completed one full year of service, though the date of increment falls on the next day of his retirement. Applying the said judgment to the present case, the writ petition is allowed and the impugned order passed by the first respondent - Tribunal dated 21.03.2017 is quashed. The petitioner shall be given one notional increment for the period from 01.07.2012 to 30.06.2013, as he has completed one full year of service, though his increment fell on 01.07.2013, for the purpose of pensionary benefits and not for any other purpose. No costs."

8. In view of the above Judgment, the applicant is allowed to increment due on 01.07.2016 for the purpose of pensionary benefits and not for any other purpose as mentioned in the above judgment of Hon'ble

High Court. Accordingly, pension of the applicant should be revised **within three months** time from the date of this order.

9. With the above directions, **O.A.** is disposed of with no order as to costs.

Department has given Sensitive and more Sensitive Area in details.

4. It appears that Home Department G.R. and Planning Department G.Rs. might be having separate opinion about more Sensitive and Hyper Sensitive Area. Respondents in there reply in para no. 4 have mentioned certain facts which are below:-

"It is submitted that as per the corrigendum dated 26.10.2016 issued by respondent no. 1, the benefits of additional incentive of 1.5 times of salary was extended to the police personnel serving with Wireless Section and Motor Transport Section of Pranhita and Gadchiroli. Accordingly, this office vide its order dated 10.11.16 directed the concerned Clerical Staff for providing additional incentive of 1.5 times of salary to the deserving personnel. Howsoever, the orders issued by the office of the respondent no. 2 dated 10.11.2016 in the matter of disbursing of 1.5 times of incentive alongwith the salary of Police Personnel was misinterpreted by clerical staff of account section. Consequently, the police personnel posted at sub headquarters, Pranhita, who did not deserve the same were also given the benefits of incentive in terms of 1.5 times of salary."

5. Therefore, the applicant was given benefits of Hyper Sensitive Area vide order

dated 10/11/2016 (Annexure-A-8, P.B., Pg. No. 36) and it was for the period from 01st April, 2016 to 31st March, 2018. However, respondents vide order dated 24/01/2017 (Annexure-A-9, P.B., Pg. No. 37) have cancelled the order dated 10.11.2016. Hence, this order is remanded back to respondent no. 2 to take appropriate decision within two weeks from the date of this order. While taking decision respondent no. 2 must justify with speaking order about the order dated 24.01.2017 (Annexure-A-9, P.B., Pg. No. 37) and the same decision must be communicated to the applicant and Tribunal through Id. P.O..
