3. I failed to understand when the applicant was granted first time bound promotion considering his date of appointed as 14/12/1993

and vide letter dated 02/12/2010 from 15/12/2005.

4. So the applicant got aggrieved as per letter dated 02/12/2010 (P-29) so the applicant should have approached before this Tribunal before time limit as given Section 21 of the Maharashtra Tribunals Act,1985. The O.A. was filed on 24/11/2017. The learned counsel for the applicant desires sometime to justify this 7 years delay.

- 3. It appears that in the Maharashtra Civil Services (Discipline & Appeal) Rules, 1979 Part-III, clause 5 (1) & (iv) it is related with withholding of increment from future years. In this peculiar order, the respondents have stopped previous increments of the year 2014 & 2015 by the impugned order dated 30/5/2016 which has been already paid to the applicant. There is no provision in the Maharashtra Civil Services (Discipline & Appeal) Rules, 1979 to

award such kind of punishment. In view of this, the order dated 30/5/2016 (A-14,P-78 to 80) passed by the respondents is quashed and set aside on technical ground. Consequent to that appeal order at Annex-A-1,P-10&11 is also quashed and set aside. The respondents are directed that if at all any recovery has been already made that amount should be refunded back to the applicant.

- 4. However, the respondents are at liberty to pass appropriate fresh order as per the provisions given in the Maharashtra Civil Services (Discipline & Appeal) Rules, 1979 and as per other prevailing rules.
