The next contention is that after having worked for more than 12 years in the areas declared to be Naxal affected by the State of Maharashtra, now, respondent Nos.4 and 5 are seeking to reduce the said benefit and have proposed to pay the petitioners time bound promotional pay scale, which cannot be done in view of the law laid down by the Co-ordinate Bench of this Court at Principal Seat, Mumbai in Writ Petition *Nos.*9543 of 2021 and connected matters, decided on 14<sup>th</sup> July 2021.

4. In these cases following interim relief was sought-

v) By way of Interim Order direct the Zilla Parishad Gadchiroli to continue / restore the benefit of one step promotional pay scale to the petitioners till they are working in the Naxal and Tribal Area Gadchiroli District under the Government Resolution dated 06/08/2002 (Anex No. ) and direct not to recover any excess payment paid under the one step promotional pay scale after completion of 12 years during the pendency of present petition and stay to the recovery if any regarding the excess payment in one step promotional pay scale paid after 12 years service from the petitioners;

Said relief was granted by the High Court.

2. The applicant appeared in the examination for the post of Police Constable (Driver) in the office of respondent no. 3 i.e. Commissioner of Police. The applicant was successful in the examination. The applicant was selected for the post of Police Constable (Driver). Thereafter the inquiry was conducted by the respondents about the character of the applicant. The applicant had given details about her in the information form. The applicant had stated that there was a crime number 15/2013 registered by Police Station Parshivani against her and offence punishable under Section 379, 511 of Indian Penal Code was registered. Thereafter the said offence was withdrawn by the complainant and he was acquitted by the court. On the basis of the report submitted to the respondents, the order was passed on 04.10.2022 stating that applicant was prosecuted by the punishment under Section 379, 511 of I.P.C. and therefore, she was not recommended for the appointment of Police Constable (Driver). Hence, the applicant approached to this Tribunal.

3. Heard ld. C.P.O., he has strongly objected for granting any stay at this stage. Ld. counsel for the applicant has pointed out the guidelines given by the Hon'ble Apex Court in the case of **Avtar Singh Vs. Union of India & Ors. (2018) 1 SCC 268.** He has also pointed out the Judgment of Hon'ble Apex Court in the case of **Pawan Kumar Vs. Union of India & Another (2022) SCC Online SC 532.** 

4. There is no dispute that applicant is selected for the post of Police Constable (Driver). The applicant has not suppressed any information from the department even at the time of filling the form

she has written that Crime Number 15/2013 was registered against her under Section 379 & 511 of I.P.C.. The said case was compounded and she was acquitted by the Judicial Magistrate First Class as per Section 320 of C.R.P.C.. This fact is also noted during the verification it was reiterated that applicant was prosecuted under offence 379 and 511 of I.P.C, the said case was compounded between the applicant and complainant.

5. As per the guidelines given by the Hon'ble Supreme Court in the case of **Avtar Singh Vs. Union of India & Ors. (2018) 1 SCC 268.** As per one of the guideline "*In case when fact has been truthfully declared in character verification form regarding pendency of a criminal case of trivial nature, employer, in facts and circumstances of the case, in its discretion, may appoint the candidate subject to decision of such case*". Nothing is pointed out in the report about the value of the stolen property.

6. In view of the guidelines of the Hon'ble Apex Court in the case of Avtar Singh (supra) and in view of the guidelines in G.R. dated 19.07.2017 the applicant is entitle for interim relief. Hence, the following order:-
