2. In response to the advertisement dated 11.03.2016 the applicant applied for the post of Regular Field Worker. He was given an appointment by order dated 29.01.2018 from Sports Quota. By order dated 28.05.2021 the applicant was confirmed with effect from his initial date of appointment. The applicant was given appointment on the basis of his participation in Power Lifting competition. He had produced the certificate to this effect. It was verified by respondent no. 3.

3. By the impugned order dated 20.09.2022 services of the applicant have been sought to be terminated on the following ground:-

"मा. उपसंचालक, किडा व युवक सेवा, नागपूर विभाग नागपूर यांचे पत्र कमांक जा.क./%%खेआ/प्रपअह/पावरलिफिटींग/रद्द/२०२२-२३/१२५ दिनांक २२.०७.२०२२ नुसार पॉवरलिफटींग हा खेळ ऑलिम्पीक किडा स्पर्था, एशियन गेम्स, कॉमनवेल्थ गेम्स या स्पर्धेत खेळला जात नाही. त्यामुळे पॉवरलिफटींग खेळाचे खेडाळूंना या अगोदर देण्यात आलेले वैध प्रमाणपत्र पडताळणी अहवाल परिशिष्ट - क रद्द करण्याचे निर्देश मा. आयुक्त, किडा व युवक सेवा संचालनालय, महाराष्ट्र राज्य पुणे यांनी दिले आहे. करीता संदर्भ क्रमांक ६ नुसार देण्यात आलेले खेडाळू प्रमाणपत्र पडताळणी अहवाल परिशिष्ट - क रद्द करण्यात येत आहे. तरी खेडाळू आरक्षण अंतर्गत श्री अशोक रामराव केदार यांना नियुक्ती देण्यात येउ नये. अथवा नियुक्ती दिलेली असल्यास रद्द करण्यात यावे. असे निर्देश या कार्यालयास प्राप्त झाले आहे."

4. It is submitted on behalf of the applicant that when the applicant was given an appointment he was eligible, this was duly recognised, certificate produced by him was verified and in due course he was also confirmed. On the basis of this chronology order dated 20.09.2022 is challenged.

5. It is submitted that the relevant Rule which is sought to be relied upon by the respondents to support the impugned order could not have been made applicable retrospectively. We find merit in his submission.

6. It is further pointed out that the impugned order was passed without giving opportunity of hearing to the applicant.

7. The applicant has also relied on order dated 29.07.2022 passed by this Tribunal in O.A. No. 775/2022. Perusal of said order which is at A-6 shows that it squarely applies to the fact of this case.

8. It is also submitted on behalf of the applicant that the Hon'ble High Court Bombay has also passed order of stay in identical set of facts.

9. On behalf of the respondents grant of interim order i.e. stay to the impugned order, is resisted.

10. On considering submissions made on behalf of the applicant and papers annexed to the O.A. including order dated 29.07.2022 passed by this Bench we have come to the conclusion that effect and implementation of the impugned order dated 20.09.2022 is required to be stayed. Effect and implementation of the impugned order is accordingly stayed till returnable date. **Respondent no. 4 is directed to allow the applicant to join his duty without giving effect to the termination order**.

11. Issue notice to Respondents, returnable on <u>four weeks</u>. Learned P.O. waives notice for R-1. Hamdast allowed.

12. Tribunal may take the case for final disposal at this stage and separate notice for final disposal shall not be issued.

13. Applicant is authorized and directed to serve on Respondents intimation / notice of date of hearing duly authenticated by Registry, along with complete paper book of O.A. Respondent is put to notice that the case would be taken up for final disposal at the stage of admission hearing.

14. This intimation / notice is ordered under Rule 11 of the Maharashtra Administrative Tribunal (Procedure) Rules,1988, and the questions such as limitation and alternate remedy are kept open.

15. The service may be done by Hand delivery, speed post, courier and acknowledgement be obtained and produced along with affidavit of compliance in the Registry within one week. Applicant is directed to file Affidavit of compliance and notice.

16. In case notice is not collected within <u>three days</u> and if service report on affidavit is not filed <u>three days</u> before returnable date. Original Application shall stand dismissed without reference to Tribunal and papers be consigned to record.
