2. By judgment and order dated 01.03.2022, the Principal Bench of this Tribunal has quashed and set aside seniority lists of Supply Inspecting Officer, Grade-B (Gazetted) dated 27.01.2020 and 12.02.2020. This order is passed in O.A. No. 220/2020.
