2. There is a mistake in the surname of respondent no.4. The learned counsel for the applicant is permitted to correct the surname of respondent no.4.

7. The applicant is challenging the promotion of respondent no.4. Without hearing respondent no.4 it will not be proper to grant any interim relief. Moreover, the rotation as submitted by the applicant is to be seen after the receipt of reply. From the perusal of communication of respondent no.2 i.e. Collector, Gondia in the meeting it was decided as per Clause 5.2 as under-

तरी हे नोटीस मिळाल्यापासून ४८ तासांच्या आत हजर झाला नाही तर आपल्याविरुद्ध म.ना.से. (शिस्त व अपिल) नियम १९७९ मधील नियम ८ नुसार शिस्तभंगाची कार्यवाही करण्यात येईल याची नोंद घ्यावी.

6. At P. 43A there is representation dated 10.08.2023 made by the applicant. This representation *inter alia* states:-

मी पशुधन विकास अधिकारी या पदावर कार्यरत असतांना प. वै. द श्रेणी.१ कोठी, ता. भामरागड, जि. गडचिरोली येथे काम केले आहे, तसेच सहाय्यक आयुक्त पशुसंवर्धन या पदावर माझी पहिली नियुक्ती जि.प.उ.आ. कार्यालय

गडचिरोली येथे झाली होती. मागील बदलीच्यावेळी २०१९ मध्ये मी नागपूर येथे बदली करित अर्ज केला होता परंतु माझी बदली नागपूर पासून १०० km दूर ता. ल. प. स. चि. नागभीड जि. चंद्रपूर तेथे करण्यात आली. ज्यांचे पाल्य सेरेब्रल palsy सारख्या आजाराने ग्रस्त आहेत त्यांची बदली २० km च्या परिघात करण्यात यावी असा शासन आदेश आहे. तरीदेखील माझी बदली नागभीड तेथे करण्यात आली. या वेळी देखील माझी बदली नागपूर पासून १८० km दूर ता. ल. प. स. चि. मुल, जि. चंद्रपूर यां नक्सलग्रस्त ठिकाणी करण्यात आली आहे. दोन वेळा नक्सलग्रस्त भागात सेवा दिल्यानंतर देखील माझी बदली परत नक्सलग्रस्त भागात करण्यात आली आहे हा माझ्यावर अन्याय आहे असे मला वाटते.

7. At P. 44 (A-7) there is notice dated 17.08.2023 issued to the applicant which states:-

8. The applicant is also relying on G.R. dated 06.08.2022 in support of what she has stated in her representation dated 10.08.2023.

9. It is submitted that respondent no. 1 be directed to consider representation of the applicant dated 10.08.2023, within the stipulated time. Case is made out to issue such directions.

10. It is submitted by Id. C.P.O. that sufficient time be given to respondent no. 1 so that representation of the applicant dated 10.08.2023 can be decided.

11. It is further submitted by Id. In the facts and circumstances of the case such order deserves to be passed.

12. Respondent no. 1 shall decide representation dated 10.08.2023 made by the applicant within 15 days from today. Till the representation is decided no coercive action shall be taken against the applicant pursuant to notices dated 07.08.2023 and 17.08.2023.

13. With these directions, **O.A. is disposed of with no order as to costs.**
