2. Ld. Counsel for the applicant seeks permission to add C.E.O., Z.P., Bhandara as party respondent. Permission is granted. The impleadment shall be carried out forthwith.

3. By the impugned order dated 15.05.2023 (A-1) the applicant is transferred from Lakhandur, Dist. Bhandara to Pindkepar, Dist. Bhandara.

4. Grievance of the applicant is that as per G.R. dated 06.08.2022 he ought to have been posted at a place of his choice. At P. 40 there are options given by the applicant for posting on transfer (A-6).

5. The applicant has relied on order dated 13.06.2018 passed by this Tribunal in O.A. No. 397/2018. This said order reads as under:-

"(i) The O.A. stands disposed of with direction to respondent No. 1 to considered the representations filed by the applicant on 4.6.2018 and 7.6.2018 for his transfer at the place of his choice.
(ii) Such representation shall be decided within a period of one month from the date of this order and till that time, the applicant shall not be relieved from Belati.
(iii) The respondent No.1 may take a decision on the representation of the applicant as per its own merits.
(iv) No order as to costs."

6. It is further submitted on behalf of the applicant that the order of relieving the applicant came to be communicated to him late in the evening.

7. The applicant prays for grant of order of status-quo so that he can continue to work at Lakhandur.

8. Prayer for grant of interim order is resisted on three grounds:-

A. The impugned order is dated 15.05.2023. If at all the applicant was aggrieved by this order he should have approached this Tribunal earlier.

B. The applicant is already relieved.

C. The applicant has served at Lakhandur since the year 2014.

9. So far as ground no. 1 raised by the ld. C.P.O. is concerned it is the submission of ld. Counsel for the applicant that the applicant was pursuing the matter of reconsideration/ modification of the impugned order with the authorities, the applicant was given to understand that it would be modified

and he would be posted at the place of his choice according to the G.R. dated 06.08.2022 but this did not happen.

10. At this juncture the ld. C.P.O. has placed on record communications dated 18.07.2023 and 25.07.2023 to contend that but for these communications the impugned order would have been implemented much earlier. Notice dated 07.08.2023 issued by the Commissioner is also placed on record. By this notice direction was issued to immediately relieve the applicant. Considering what is stated in the communications dated 18.07.2023, 25.07.2023 and 07.08.2023 it can be prima facie inferred that but for the first two communications the impugned order would have been implemented earlier. Under such circumstances it would be necessary to hear the other side and then decide the matter finally.
