3. As per the submission of ld. Counsel for the applicant, the departmental enquiry after the acquittal in criminal trial shall not be continued. In para no. 39, The J.M.F.C., Court No. 3 has recorded finding that testimony of victim is not reliable. Her conduct subsequent to the incident as well as discrepancy in her evidence as well as in the evidence of other witnesses does not inspire confidence therefore, the evidence of prosecution does find not cogent, consistent and trustworthy to rely upon, therefore, the applicant is acquitted by the criminal court. The appellate authority also recorded the finding but remanded back to the disciplinary authority.
