2. As per the submission of learned counsel for applicant, the applicant was working as Assistant Sub Inspector in Group-C category. He retired 30/06/2011. After 11 years, the respondents have started recover of Rs.2,69,792/-.

3. The learned counsel has pointed out the decision of Hon'ble Supreme Court in case of **State Of Punjab & Ors vs. Rafiq Masih (White Washer) decided on 18 December, 2014** in Civil Appeal No. 11527 OF 2014 (Arising out of SLP(C) No. 11684 of 2012) recovery cannot be done. Para no. 12 of the said Judgment is reproduced below:-

"12. It is not possible to postulate all situations of hardship, which would govern employees on the issue of recovery, where payments have mistakenly been made by the employer, in excess of their entitlement. Be that as it may, based on the decisions referred to herein above, we may, as a ready reference, summarise the following few situations, wherein recoveries by the employers, would be impermissible in law:-

- (i) Recovery from employees belonging to Class-III and Class-IV service (or Group 'C' and Group 'D' service).*
- (ii) Recovery from retired employees, or employees who are due to retire within one year, of the order of recovery.*
- (iii) Recovery from employees, when the excess payment has been made for a period in excess of five years, before the order of recovery is issued.*
- (iv) Recovery in cases where an employee has wrongfully been required to discharge duties of a higher post, and has been paid accordingly, even though he should have rightfully been required to work against an inferior post.*

(v) In any other case, where the Court arrives at the conclusion, that recovery if made from the employee, would be iniquitous or harsh or arbitrary to such an extent, as would far outweigh the equitable balance of the employer's right to recover."

4. The applicant is a Group-C employee/ officer and he retired before 11 years and in view of guidelines of Hon'ble Supreme Court in case of **State Of Punjab & Ors vs. Rafiq Masih (White Washer) (cited supra)** the recovery is not permissible. Hence, **the impugned recovery order dated 12/7/2022 (A-1,P-12) is hereby stayed till filing of reply.**

5. Issue notice to the respondents returnable **after four weeks**. Learned P.O. waives notice for State. Hamdast allowed.

5. The Hon'ble Bombay High Court in the case of **Vasant K. Kamble Vs. State of Maharashtra and another, 2003 (4) Mh.L.J.,606** and the Hon'ble Supreme Court in

case of **Krishnakant R. Bibhavnaekar Vs. State 1997 (3) SCC,636**, have held that it is a **prerogative** of the disciplinary authority to decide about the suspension period and Court cannot interfere or direct the authority to treat the suspension period as a duty period. Hence, the Court / Tribunal cannot interfere in the authority of respondents. It is for the respondents to decide as to whether suspension period is a duty period or other.

6. In that view of the matter, the O.A. is disposed off. The C.A. also stands disposed off accordingly. No order as to costs.
