2. The ld. Counsel for the applicant submits that certain documents which he had placed on record in O.A. No. 351/2019 on P-100 (A) onwards, it is copy of Police Station Dairy belongs to Police Station Frezarpura, Amravati City dated 18.10.2015 (P. 100-A), dated 19.10.2015 (P. 101), dated 21.10.2015 (P. 102) and dated 28.10.2015 (P. 103) have not been considered while deciding the original application.

3. In view of these facts, as per order XLVII-Rule 1 of C.P.C., it appears *prima facie* error on the part of consideration of documents. Hence, **Review Application is allowed.**

4. Ld. Counsel for the applicant has pointed out the impugned order dated 23.12.2015 (A-5, P. 70) and submits that as mentioned in the impugned order, respondent no. 2 gave direction to Police Inspector Solanke (incharge officer) and not directly to the applicant. Subsequently, Police Inspector Solanke passed this direction on 19.10.2015 in writing to the applicant. Ld. Counsel for the applicant has produced copy of Police Station Dairy dated 18.10.2015, 19.10.2015, 21.10.2015 & 28.10.2015 which are reproduced below :-

5. Wherein on 21.10.2015 at P. 9 of the Review Application, it is mentioned that ultimately applicant succeeded in catching criminal like Siraj Khan and moved to produce before respondent no. 2. On again as per diary dated 28.10.2015 at P. 10, he succeeded in catching Bharat Chedilal Chaudhary residence of Yasodaranagar No. 1, Amravati and produced him for medical examination.

6. By these documents, it appears that though direct order was given by respondent no. 2 to Police Inspector Solanke and Solanke gave the order in writing on 19.10.2015 to applicant, applicant made the efforts as per the directions given by his superiors which is reflected in Police Station Frezarpura dairy from 18.10.2015, 19.10.2015, 21.10.2015 and 28.10.2015. The Police Dairy of 18.10.2015, 19.10.2015, 21.10.2015 and 28.10.2015 are on record. His efforts also relates in catching hold of culprit Siraj Khan and Bharat Chedilal Chaudhary.

7. Perusal of his efforts and results there upon it appears that impugned order dated 23.12.2015 by respondent no. 2 is harsh and disproportionate to the applicant. However, it is admitted fact that applicant should have also done these efforts on his own without

waiting directions of his superiors i.e. respondent no. 2 or Police Inspector Solanke.

8. Considering all these rival submissions and documentary evidence, the punishment order is modified in the following way:-
