- 2. The learned counsel for the applicant pointed out the amended prayer Clause ix-(a) of the O.A. (Page no.26). He has pointed out the suspension order dated 24/06/2020. The learned counsel for the applicant has submitted that the respondents used to suspend and without any inquiry, they used to reinstate the applicant. Earlier suspension orders were revoked and he was taken on duty without any inquiry. Again he was suspended on 24/06/2020.
- 3. The learned counsel for the applicant has pointed out the Judgment of Hon'ble Supreme Court in the case of *Ajay Kumar Chaudhary Vs. Union of India through its Secretary and another*. The Apex Court in Civil Appeal No. 1912 of 2015 (arising out of SLP No.31761 of 2013) in the case of *Ajay Kumar Chaudhary Vs. Union of India through its Secretary and another* in its Judgment dated 16/02/2015 in para no. 14, it is observed as under-
- "14. We, therefore, direct that the currency of a Suspension Order should not extend beyond three months if within this period the Memorandum of Charges/Chargesheet is not served on the delinquent officer/employee; if the Memorandum of Charges/Chargesheet is served a reasoned order must be passed for the extension of the suspension. As in the case in hand, the Government is free to transfer the concerned person to any Department in any of its offices within or outside the State so as to sever any local or personal contact that he may have and which he may misuse for obstructing the investigation against him. The Government may also prohibit him from contactingany person, or handling records and documents till the stage of his having to prepare his defence. We think this will adequately safeguard the universally recognized principle of human dignity and the right to a speedy trial and shall also preserve the interest of the Government in the prosecution. We recognize that previous Constitution Benches have been reluctant to quash proceedings on the grounds of delay, and to set time limits to their duration. However, the imposition of a limit on the period of suspension has not been discussed in prior case law, and would not be contrary to the interests of justice. Furthermore, the direction of the

Central Vigilance Commission that pending a criminal investigation departmental proceedings are to be held in abeyance stands superseded in view of the stand adopted by us."

- 4. The State of Government has also issued G.R. GAD dated 09/07/2019 after the Judgment of Hon'ble Supreme Court in the case of *Ajay Kumar Chaudhary Vs. Union of India through its Secretary and another*. The relevant para nos. 1 (i, ii & iii) of the G.R. dated 09/07/2019 is reproduced as below -

- (ii) निलंबित शासकीय सेवकांच्या ज्या प्रकरणी ३ महिन्यांचा कालावधीत विभागीय चौकशी सुरू करून दोषारोप पत्र बजावण्यात आले नाही, अशा प्रकरणी मा. सर्वोच्च न्यायालयाचे आदेश पाहता, निलंबन समाप्त करण्याशिवाय अन्य पर्याय राहत नाही. त्यामुळे निलंबित शासकीय सेवकांबाबत विभागीय चौकशीची कार्यवाही सुरू करून दोषरोप पत्र बजावण्याची कार्यवायी निलंबनापासून ९० दिवसांच्या आत काटेकोरपणे केली जाईल याची दक्षता/ खबरदारी घेण्यात यावी.
- (iii) फोजदारी प्रकरणात विशेषतः लाचलुचपत प्रकरणी निलंबित शासकीय सेवकांवर विभागीय चौकशी सुरू करून दोषारोप पत्र बजावणेबाबत आवश्यक तो अभिलेख लाचलुचपत प्रतिबंधक विभागाने संबंधित प्रशासकीय विभागास उपलब्ध करून देणे आवश्यक राहिल.
- 5. The State Government has given guidelines to the concerned Officer to complete the inquiry within a period of 90 days. If the inquiry is not completed within stipulated period of 90 days, the suspension shall be revoked.
- 6. It appears that the applicant is under suspension since 24/06/2020. As per the submission of learned counsel for the applicant, though the suspension order is passed on 24/6/2020, the inquiry is commence, but there is no progress in the inquiry.
- 7. In view of the Judgment of Hon'ble Supreme Court in the case of *Ajay Kumar Chaudhary Vs. Union of India through its Secretary and another* and Government GAD G.R. dated 09/07/2019, the suspension order dated 24/06/2020 passed by respondent no.7 is hereby revoked. The respondents are directed to reinstate the applicant.
