2. This Tribunal as per order dated 06.05.2022 directed the respondent to relieve all applicants forthwith and they should be presumed that they have been relieved from the date of issue of the order dated 08.02.2022. The para-4 of order dated 06.05.2022 is reproduced as under:-

4. *In view of these, following order :-*

i) Applicants at Sr.Nos.4, 5, 6, 7 & 8 in order dated 08.02.2022 should be relieved forthwith and it should be presumed that they have been relieved from the date of issue of this order dated 08.05.2022.

ii) Accordingly in their service book also entry should be made to avoid further confusion to the seniority list.

3. The respondents have not complied the order dated 06.05.2022. Instead of complying the said order, the C.A.No.210/2022 is filed for modifying the order on the ground that the department is now facing the shortage of manpower on the post of applicants.

4. It was expected from the respondents to comply the order dated 06.05.2022. The promotion order dated 08.02.2022 is very clear and as per the Clause nos. 9, 10 and 11 (P-20), the applicants were directed to join immediately on the promotional post. The respondents themselves have issued the promotion order and Clause no. 11 shows that the applicants were directed to join on their promotional post within a

period of 30 days. All the applicants who were promoted; were directed to join immediately and the Head of the Department were directed to relieve them immediately.

5. Learned P.O. has submitted that due to shortage of manpower, the respondents are not able to relieve the applicants and therefore the order dated 06.05.2022 needs to be modified.

6. Learned counsel for the applicants has submitted that though applicants were promoted in the month of February 2022, they are not getting promotional pay. The respondent / authority wants to keep them on the same post and therefore they have not issued relieving order to join them on the transferred / promoted post. Applicants are promoted and transferred as per order dated February 2022, and they were directed to join immediately. Then, it was the duty of the respondents to relieve them immediately. There is nothing ambiguity/ illegality in the order dated 06.05.2022. Hence, **C.A is dismissed. Respondents are directed to comply the order dated 06.05.2022 within a period of fifteen days.**
