He has pointed out qualification of the applicant at P. 60 (Sr. Nos. 5 & 6). Applicant has passed M.Sc. and Ph.D. in Chemistry, he has published 31 publications.

3. Ld. Counsel for the applicant has pointed out recruitment rules at P. 72. He has further pointed out Rule 8 and submitted that applicant is eligible for the post of 'Director' because the applicant is having more than 18 years of experience of Research in the subject of Forensic Science and Chemistry. Ld. Counsel has pointed out that in the scrutiny report, it is wrongly calculated that applicant is not having experience of 18 years (P. 87) and therefore, he is declared ineligible for the interview.

4. Rule 8 is reproduced below:-

"Appointment to the post of Director, Forensic Science Laboratories, Maharashtra State and Chemical Analyser to Government in the Directorate be made either :-

a. By promotion of a suitable person on the basis of selection from amongst the persons holding the post of Joint Director in the Directorate and possessing the qualification prescribed for appointment by nomination in sub clauses (ii) & (iii) of clause (b) of this rule; or

b. By nomination from amongst the candidates who;

*i.* Unless already in the service of Government are not more than fifty years of age;

ii. Possess Master's degree at least in second class or Doctorate
 degree in (A) any branch of Chemistry or Biochemistry; or (B) Physics,
 Botany or Zoology with a degree in Chemistry; and

iii. Possess minimum eighteen years experience of research of a recognised merit in any of the subjects mentioned in sub-clause (ii) or in Forensic Science gained after acquiring the qualifications mentioned in sub-clause (ii) and possess adequate analytical experience after obtaining the essential academic qualification."

5. The recruitment rules are the material for deciding the qualification of the eligibility of the candidate for the post. As per recruitment rules 8 (2)(iii) material qualification is that the candidate must have 18 years experience in any of the subject mentioned in Sub Clause 2 or in Forensic Science Laboratory. As per submission made by the ld. Counsel for the applicant, applicant is having 21 years of experience. He is M.Sc., Ph.D. and he has published 31 publications, therefore, he is eligible for the post advertised by the respondents.

6. From the perusal of scrutiny report, it appears that candidates were to be given opportunity before the interview to produce all the documents and after verification of documents decision be taken as to whether he should be allowed for interview or not? Even the scrutiny report is taken into consideration then also it appears that the respondents have not called the applicant before the interview for verification of the original documents. Considering the scrutiny report, he is declared ineligible candidate. The documents of the respondents itself shows that opportunity will be given to the applicant before the interview for the verification of original documents. Last para of the scrutiny report produce has under:-
