2. The learned counsel for the applicant has pointed out the advertisement dated 24/02/2023. By this advertisement, two posts are advertised for filling the vacancy of Assistant Director in State Sericulture Service, Group-A.

3. The learned counsel for the applicant has pointed out the Clause 8 (i) and submitted that this is against the principles of Article 14 and 16 of the Constitution of India. He has submitted that the applicant is having the degree of Biotechnology, but he has not passed in 1st class. The conditions mentioned in the advertisement that the candidate should possesses the degree in Science Agriculture / Sericulture/Biology/ Zoology/ Botany or Textile Engineering in 1st class.

4. The learned counsel for the applicant has pointed out the similar advertisements in respect of other posts of other departments i.e. advertisements dated 21/10/2022 and 30/09/2022 are in respect of Electrical Department and Technical Department.

5. The learned counsel for the applicant has submitted that those advertisements show in respect of Group-A posts and there were no conditions in those advertisements for passing degree in 1st class. The learned counsel for the applicant has submitted that the applicant is qualified. He is working as a Development Officer in Sericulture Department. He is having the degree, but not in 1st class.

6. The learned counsel for the applicant has pointed out the Rule 3 (ख) (एक) (दोन) of the Recruitment Rules dated 12/04/2010 and submitted that this Rule is not proper because passing of degree in 1st class cannot be said to be mandatory.

7. The learned counsel for the applicant has submitted that that the Rule for Group-B post was amended as per the Notification dated 04/06/2014 and as per the amended rules, those who have passed degree in Agriculture, Sericulture, Botany, Zoology and Textile Engineering or Biotechnology passed in 2nd class, are eligible for the Group-B post.

As per his submission, the applicant is having degree, but not in 1st class, therefore, he should be given chance to appear in the examination as per the advertisement dated 24/02/2023.

9. Heard learned C.P.O. Shri S.A. Deo, for State / respondent. He has strongly objected the same. He has submitted that Rule 3 (ख) (एक) (दोन) is applicable to all. As per the Recruitment Rules dated 12/04/2010, the advertisement is issued by the respondents to fill the post of Assistant Director in State Sericulture Service, Group-A. The learned CPO has submitted that the applicant is not eligible for the post because he is not having degree in 1st

class and therefore the respondents cannot be directed to allow the applicant to appear in the examination as per the advertisement dated 24/02/2023.

10. The main contention of the applicant is that the Rule 3 (函) (एक) (ोल) is against the Article 14 and 16 of the Constitution of India. This issue is decided by the Full Bench of M.AT., Principal Bench, Mumbai in O.A. No.144 of 2022 with connected matters on 17/03/2023. The same issue was involved before the Full Bench of M.AT., Principal Bench, Mumbai as to whether the conditions mentioned in the advertisement is against the Article 14 & 16 of the Constitution of India. The Full Bench of M.AT., Principal Bench, Mumbai has decided the issue holding that it is not against the Article 14 and 16 of the Constitution of India, because, the condition is applicable to all aspirant candidates and not a particular candidate. The Rule 3 (函) (एक) (ोल) is applicable to all and not for a particular person like this applicant and therefore it cannot be said that it is against the Article 14 and 16 of the Constitution of India.

11. The learned counsel for the applicant has pointed out the advertisement issued by other Departments, that is not related to the advertisement issued by the respondents dated 24/02/2023. Therefore, those advertisements cannot be taken into consideration. There was some intention to get the meritorious candidates to be appointed for the post of Assistant Director in State Sericulture Service, Group-A. Those who have passed the degree as stated in Rule 3 ($\overline{\alpha}$) ($\overline{v}\overline{\alpha}$) mentioning that the candidate who is having degree in 1st class can apply for the post of Assistant Director in State Sericulture Service, he is not eligible to apply for the said post.

12. The advertisement is issued in consonance with Rules dated 12/04/2010. Nothing is pointed out to show that the advertisement is contrary to the Rules dated 12/04/2010. The Rules framed under the Article 309 of the Constitution of India is applicable to all the candidates and not a particular person. Therefore, there is no breach of Article 14 and 16 of the Constitution of India as held by the Full Bench of M.AT., Principal Bench, Mumbai in O.A. No.144 of 2022 with connected matters as per order dated 17/03/2023. Therefore, the applicant cannot be permitted to appear in the examination as per advertisement dated 24/02/2023.

13. In view of above discussion, the O.A. appears to be decided on merit interpreting the Rules dated 12/04/2010 and the conditions mentioned in advertisement dated 24/02/2023. The material grievances of applicant as prayed in the present O.A. is decided. Hence, there is no necessity to issue notice to the respondents. Hence, we pass the following order –
