4. The learned counsel for the applicant has submitted that as per order dated 13.05.2022 if promotion orders are issued that will be subject to outcome of the O.A. The learned counsel submits

that respondents are promoting certain employees, they are reminded, it will amount to Contempt of Court and if they are promoted, they will face consequences of Contempt of Court. If at all such orders are issued these orders should be withdrawn forthwith in the light of order dated 13.05.2022 of this Tribunal and first decide representation of the applicant and then take further action.
