६) अधिकारी/कर्मचारी यांचेकडून बदलीसाठी पसंतीक्रम प्राप्त होताच सक्षम प्राधिकाऱ्यांनी संबंधितांचा विहित कार्यकाल संपताच त्यांच्या पसंतीच्या जिल्ह्यात बदलीसाठी आवश्यक ती कार्यवाही करावी. काही प्रशासकीय कारणास्तव पसंतीच्या जिल्ह्यात लगेचच बदली करणे शक्य नसल्यास सक्षम प्राधिकाऱ्यांने अशी प्रकरणे तातडीने वरिष्ठांचे/शासनाचे निदर्शनास आणून देवून त्यांचे आदेश प्राप्त करावेत व संबंधितास तसे कळवून त्यांना अन्यत्र बदली द्यावी. मात्र, असे करताना संबंधितांनी बदलीसाठी दिलेला पसंतीचा हक्क पुढील तीन वर्षापर्यन्त कायम ठेवून या वाढीव कालावधीत पसंतीच्या जिल्ह्यात बदली देणे आवश्यक राहिल.

3. On the same day the applicant made a representation (A-6). Said representation has not been decided as yet.

4. It is submitted on behalf of the applicant that if this Tribunal is inclined to direct respondent no. 1 to decide the representation dated 15.05.2023 within the stipulated time, interim order be passed that in the meantime no coercive action shall be taken against the applicant. To show that this appreciation of the applicant is not unfounded,

attention is invited to para no. 10 of order dated 10.08.2023 which reads as under:-

*“10. At this juncture the ld. C.P.O. has placed on record communications dated 18.07.2023 and 25.07.2023 to contend that but for these communications the impugned order would have been implemented much earlier. Notice dated 07.08.2023 issued by the Commissioner is also placed on record. By this notice direction was issued to immediately relieve the applicant. Considering what is stated in the communications dated 18.07.2023, 25.07.2023 and 07.08.2023 it can be prima facie inferred that but for the first two communications the impugned order would have been implemented earlier. Under such circumstances it would be necessary to hear the other side and then decide the matter finally.”*

5. It is also submitted that the applicant was relieved on 09.08.2023 and presently he is on medical leave.

6. Taking into account all the relevant circumstances it would be proper to direct the respondent no. 1 to decide representation dated 15.05.2023 (A-6) within four weeks from today. In the facts and circumstances of the case interim protection as sought by the applicant also deserves to be granted. **Respondent no. 1 shall decide representation dated 15.05.2023 (A-6) on its own merits within four weeks from today. Till then no coercive action shall be taken against the applicant.**
