2. In O.A.No.800/2020, C.A.No.178/2020 was moved by the applicant was condonation of delay. That application was rejected by this Tribunal, as per order dated 17.09.2021. The reasons are recorded in para 3, 4 and 5 of the order.

3. *It appears that the respondent no4 has written letter dated 10/11/2009 (A-6, P-20) to the applicant's mother communicating that his application is pending with the DCP office. It also appears that vide Govt GAD letter dated 21/2/2012 (A-3, P-16) communicating to the Superintendent of Police, Yavatmal, i.e. the respondent no. 4 regarding rejecting application of applicant. This communication is done on 21/2/2012 only.*

4. *The learned counsel for the applicant has filed O.A. No 503/2015 passed by the MAT.. Bench at Mumbai on 5/4/2016 (A-10, P-39). After going through this Judgment, it appears that the said Judgment is not relevant in this matter.*

5. *In view of above observations it appears that except representations, no other cogent reason is given for condoning the delay Hence, the C.A. and O.A. (St.) stand dismissed. No order as costs*

3. The learned counsel for the applicant has pointed out the order passed by this Tribunal dated 13.03.2023. That order is reproduced below-

2. *On last hearing applicant was asked to file citations. Today he has filed judgment in O.A. No. 151/2022 delivered on 06.12.2022 of M.A.T., Nagpur Bench and judgment in O.A. No. 191/2022 delivered on 19.09.2022. Further Id. Counsel for the applicant has also filed judgment of Hon'ble High Court in W.P. No. 6267/2018 delivered on 11.03.2020. Though all these judgments covers the point that applicant's name should be substituted in place of his mother in compassionate appointment but from which date it should be included or from which date his seniority shall be maintained that is not mentioned.*

3. *Ld. Counsel for the applicant is directed to file application of applicant on affidavit to include his name after becoming major and seniority to be maintained from the date of his application.*

4. As per the direction of this Tribunal, the applicant has filed affidavit. As per his affidavit, he is praying to include his name in place of the name of his mother in the waiting seniority list for appointment on compassionate ground.

5. As per the submission of learned counsel for the applicant the substitution is provided. As per the Judgment of Hon'ble Bombay High Court Bench at Aurangabad in the case of ***Dnyaneshwar Ramkishan Musane vs The State Of Maharashtra And others, decided on 11 March, 2020*** and the Judgment of ***Hon'ble Bombay High Court, Bench at Nagpur in Writ Petition No.6285/2018 in the case of Anil Ramdas Pawar Vs. Union of India and Others, decided on 4 March 2020.*** In fact there is no delay name of applicant should have been included in place of the name of his mother, when the applicant attained the age of majority.

6. The learned P.O. has submitted that the O.A. was not within limitation. As per the submission of learned P.O., the name of mother of applicant was removed from the waiting seniority list in the year 2001. He wants to file documents in that respect. Therefore, condonation of delay application is liable to be dismissed.

The information / direction given by respondent no.4 in letter dated 14.07.2022 and as per telephonic communication dated 11.07.2022, termination order is issued. This letter / direction to respondent no.4 by respondent no.3 does not show that there is any amendment to the Rule. The applicant was appointed as per Rule. Even there is any amendment then also it cannot be given effect retrospectively, in view of the Judgment of Hon’ble Apex Court in the case of T.R.Kapur (Supra).*

*6. As the applicant was appointed as per Rule and he is made permanent in the service, **impugned termination order dated 25.07.2022 is hereby stayed until further order.** Respondent no. 4 is directed to allow the applicant to join his duty without giving effect to the termination order.”*

2. Grievance of the applicant is that though his son is suffering from Mental Retardation, choices given by him were not considered as per A-1 of G.R. dated 09.04.2018. In order dated 08.08.2023 it was observed:-

*“2. It is the submission of the applicant that his son is suffering from ‘Specific Learning Disorder (Writing)’ and there are two vacant posts at Nagpur which can be considered for posting him. Id. P.O. shall take instructions whether on either of these posts the applicant can be accommodated.”*

3. It is the submission of the Id. P.O. that both the posts at Nagpur mentioned in order dated 08.08.2023 have been filled up.

4. Grievance of the applicant is that these posts were filled up after the applicant had submitted an application before this Tribunal seeking necessary directions. Now the fact remains that both these posts have been filled up. In this factual scenario it is the contention of the applicant that one post at Nagpur may fall vacant on account of promotion of one Smt. Kothe. In support of this submission copy of communication dated 05.09.2023 is placed on record (marked Exh. X). The applicant now only seeks direction to the respondents to consider claim of the applicant for being posted at Nagpur on the post which may fall vacant on promotion of Smt.

Kothe - on its own merits and specially in the light of contents of A-1 to G.R. dated 09.04.2018.

5. The respondents are directed to consider claim of the applicant for being posted on the post which may fall vacant on promotion of Smt. Kothe, on its own merits and in the light of above referred guidelines contained in G.R. dated 09.04.2018.

6. With these directions, **O.A. along with C.A. stand disposed of with no order as to costs.**
