2. Office has raised an objection that applicant nos. 2, 3, 4, 6, 7, 9, 10 and 12 to 16 are not residing within the Jurisdiction of this Tribunal.

3. The learned counsel for the applicant has pointed out Rule 4(5). It is in respect of filing of Jt. Application by one or more persons (applicants), in respect of common grievances and in respect of common relief. There is no dispute about it. This Tribunal is allowing such type of applications. The main objection has raised by the office is that applicant nos. 2, 3, 4, 6, 7, 9, 10 and 12 to 16 are not residing within the Jurisdiction of this Tribunal. Therefore, as per the Rule 6 the application it is to be filed before the Bench having Jurisdiction.

4. The learned P.O. has submitted that office has not raised any objection for filing of joint original application but objection is in respect of the Jurisdiction and, therefore, Rule 4(5) is not applicable.
