2. As per the submission of ld. Counsel for the applicant, applicant obtained 57 marks in the written examination. He scored only 12 marks in the interview (oral examination). Applicant has obtained total 69 marks. Whereas other candidates namely Deepak Thakur, Vikas Thakur, Sobha Thakur and Savita Thakur obtained less marks in the written examination but they were scored more marks in the interview (oral examination). Respondent no. 5 obtained 51 marks in the written test and she was obtained 19 marks in the Interview (oral examination). Therefore, she has scored 70 marks. It is submitted by the applicant that the respondent no. 4 intentionally granted more marks to respondent no. 5 so not to appoint applicant.

3. Ld. C.P.O. submitted that there is no rule that candidate who obtained more marks in written examination should obtained more marks in interview (oral examination). Admittedly, respondent no. 5 i.e. Savita Thakur has obtained 70 marks, whereas applicant has obtained 69 marks. Therefore, it cannot be said that applicant is entitled for the relief.

4. Interim relief cannot be granted because there is no rule that the candidate who obtained more marks in the written examination should perform very well and obtained more marks in the interview (oral examination). It may be a reason that candidate who obtained more marks in the written examination he may perform less in the interview (oral examination). **Hence, interim relief cannot be granted.**
