As per the submission of learned counsel for the applicants, the applicant no.3 has appeared in the written examination for the post of Assistant Commissioner, Animal Husbandry as per the advertisement dated 18.02.2022. The applicant no.3 got 79 marks in the written examination. Cut off marks for the post of Women reserved category was 66. The applicant no.3 got more marks than the cut off marks. The applicant no.3 could not produce non-creamy layer certificate. Therefore, she is not called for interview on the ground that she has not produced non-creamy layer certificate. The learned counsel for the applicants has pointed out the Government G.R. dated 04.05.2023. The material portion of the G.R. is reproduced below-

३) (दोन) प्रमाणपत्रेमधील (क) - मागासवर्गीय उमेदवारांची खुल्या प्रवर्गातील महिलांच्या आरक्षित पदावर नियुक्ती झाल्यास त्याबाबतची प्रमाणपत्रे व त्याची तपासणीमधील (१) मधील (अ) येथील परिच्छेदातील अशा महिला उमेदवारांकडून खुल्या प्रवर्गातील महिलांकरिता विहित केलेले क्रिमिलेअरचे प्रमाणपत्र देण्याची आवश्यकता राहणार नाही.", ही तरतूद,

४) (दोन) प्रमाणपत्रेमधील (क) मागासवर्गीय उमेदवारांची खुल्या प्रवर्गातील महिलांच्या आरक्षित - पदावर नियुक्ती झाल्यास त्याबाबतची प्रमाणपत्रे व त्याची तपासणीमधील (१) मधील (ब).

३. खुल्या गटातील महिलांकरिता आरक्षित असलेल्या पदावर निवड झालेल्या महिलांच्या नॉन-क्रिमिलेअर प्रमाणपत्रांची तपासणी करण्याबाबत येणाऱ्या अडचणींचे निवारण करण्याच्या अनुषंगाने शासन निर्णय दि.२५.५.२००१ मध्ये आवश्यक तरतुदी करण्यासाठी शासन निर्णय दि.१५.१२.२०१७ निर्गमित करण्यात आला आहे. तसेच, या शासन निर्णयामधील तरतुदीबाबत येणाऱ्या अडचणींच्या अनुषंगाने स्पष्टीकरणात्मक सूचना शासन निर्णय दि.११.१.२०१९ अन्वये निर्गमित करण्यात आल्या आहेत. आता, खुल्या गटातील महिलांकरिता आरक्षित असलेल्या पदावरील निवडीकरिता नॉन-क्रिमिलेअर प्रमाणपत्र सादर करण्याची अट रद्द करण्यात आली असल्याने शासन निर्णय

3. The learned counsel for the applicants has pointed out the order passed by M.A.T., Bench at Aurangabad in O.A.st.No.2083/2023, dated 19/10/2023 by which granted the interim relief and directed the respondents to keep two posts vacant.

4. The learned counsel for the applicants has pointed out the letter issued by M.P.S.C. dated 23.10.2023. As per this letter, oral interview is to be held on 02.11.2023 and 03.11.2023. In view of the G.R. dated 04.05.2023, the applicant no.3 need not to produce non-creamy layer certificate. The applicant no.3 got 79 marks more than the cut off marks of 66 and as per G.R. dated 04.05.2023 she need not to produce non-creamy layer certificate. Therefore, respondents should have considered her candidature in the Women reserved category for the post of Assistant Commissioner of Animal Husbandry. Hence, the following order is passed.

ORDER

1. The interim relief is granted.
2. The respondents are directed to allow the applicant no.3 for interview to be held on 02.11.2023 and 03.11.2023. The result of the interview shall be kept in a sealed envelope and it will be subject to the further order of this Tribunal.
