3. Thereafter the applicant went to join at Shegaon on 16-4-2015. In the above state of affairs, the Dy. Director of Health Services,

Akola (R/3) sought the instructions from the Director of Health Services, Mumbai (R/2) vide communication dated 17-4-2015. Thereafter the Director of Health Services vide communication dated 5th June,2015 sought the instructions from the Principal Secretary of Public Health Department by giving the details. However no steps are taken by the Govt. from 5th June,2015, though period of one and half years is lapsed.

4. The applicant is ready to join and he has again sent the communication to the Principal Secretary of Health Department on 14-7-2015, but to no effect.

5. It is the experience in several matters that the administration in the Health Department has come to a standstill. In several cases it is noticed the Medical Officers are sitting idle without work as the administrative steps/actions are not taken by the department. The hue and cry is made of the dearth of Medical facilities/services. Thereby the public at large is affected adversely. However, experience is contrary as noted above.

6. The Govt. did not find any time within one and half year to take steps in the matter. It is observed in several matters that the copies of orders will be sent to the Chief

Secretary so that there will be some improvement in the department, but to no effect. The copy of this order be sent to the Chief Secretary.

7. On submission, the O.A. is disposed of with a direction to the respondents to decide the communication

dated 5th June,2015 sent by the Director of Health Services to the Principal Secretary of Public Health Department before 31-12-2016.

8. The Registrar and P.O. to send the copy of this order to the Chief Secretary to the Govt. of Maharashtra within a week and put up for compliance.
