2. It reveals that the applicant secured the higher marks. He was asked to produce the medical certificate. The applicant is physically handicapped having 49% disability as per certificate (A-8, P-28). The learned P.O. submitted that as per Rule 3 (d) of the Maharashtra Village Police Patils (Recruitment, Pay, Allowances and Other Conditions of Service) Order, 1968 a person to be appointed should be physically fit and for that physical examination should be carried out.

3. It is not clear whether applicant examined from this view point and whether he is fit or not to work as a Police Patil. As such in the light of above legal provisions, the mere certificate that the applicant is physically and mentally fit cannot be guiding factor.

4. In the above state of affairs, the SDO to write a letter to the Civil Surgeon to examine the applicant in the light of rule 3 (d) and to get ascertain whether the applicant is physically fit to do the work of Police Patil.

5. On receipt of certificate from the Civil Surgeon, the matter can be decided. The

applicant should appear before the Civil Surgeon for physical examination.
