2. The applicant was transferred from Ner to Mangrulpir vide transfer order dated 31-5-2016 (A-1,P-14). The applicant was due for transfer. The Tribunal passed order of status-Thereon applicant being 75% disability quo. physically handicapped (A-2,P-19), the department placed the matter before the Civil Services Board. The Civil Services Board in its meeting dated 17-10-2016 approved the applicant's case and vide communication dated 18-10-2016 (P-25) informed the Commissioner (Education), Pune to take the necessary steps

for prior approval. However, yet no progress in the matter.

- 3. The learned P.O. requested that one month time will be required. The period of one month and seven days is already lapsed. Though the transfer order was issued on 31-5-2016, the contention of the applicant is that he was not relieved. However, since the transfer order was issued long back, the order of statusquo was passed on 31-8-2016.
- 4. The applicant's case is that the Education Officer (Primary), Z.P., Yavatmal (R/2) is not allowing the applicant to work contending that the applicant is relieved and the order of status-quo is passed.
- 5. However, the learned counsel for the applicant submits that no person is posted at Ner from where the applicant is transferred and that post is lying vacant.
- 6. In the above circumstances, no fruitful purpose will be served if the applicant remains idle. Therefore, the Education Officer (R/2) to allow him to join and work at Ner, if the post is vacant, till 31-12-2016, i.e., issuance of order by department.

- 7. It is manifest on the communication dated 18-10-2016 that Civil Services Board has proposed the transfer of the applicant on his request. Thus the formalities are to be completed, one month period was available for that. As such further extension of one month period cannot be granted as prayed for. Respondent no.1 to take decision on that proposal on or before 31-12-2016.
- 8. With this, the O.A. stands disposed of.
