2. The learned counsel for the applicant has pointed out the advertisement dated 07/11/2022. He has submitted that the respondent no.6 committed breach of Clause-16 of the advertisement. He has also submitted that the respondent no.6 has submitted false information and applied for more than one post in the same unit. He applied for the post at Commissioner of Police, Nagpur as well as at the Police Commissioner, Mumbai. Therefore, he has committed breach of Clause-16 of the advertisement.

3. The learned counsel for applicant has pointed out the Judgment of Full Bench of the M.A.T., Principal Bench, Mumbai in O.A. 144/2022 with connected matters, decided on 17/03/2023. In the said Judgment, the Full Bench (myself was one of the members of that Judgment) has held that as per the Judgment of Hon'ble Supreme Court in the case of ***K.G. Ashok & Others Vs. Kerala Public Service Commission and Others***, the candidates cannot fill the form for more than one unit. The candidates should strictly follow the conditions mentioned in the advertisement.

4. Relying on the Judgment of Hon'ble Supreme Court in the case of ***K.G. Ashok & Others Vs. Kerala Public Service Commission and Others***, the Full Bench has passed the final order directing the respondents / police authority to appoint the candidate who has passed in the examination and who has followed the conditions mentioned in the Clause-11.10 of the advertisement. That Judgment was challenged before the Hon'ble Bombay High Court in Writ Petition No.5298/2023. The Hon'ble Bombay High Court on 20/04/2023 dismissed the Writ Petition.

5. The learned P.O. has pointed out the advertisement of this O.A. and para-25 of the Full Bench Judgment. He has submitted that the Clause-16 of this advertisement is different from the advertisement of 2019 and therefore the applicant cannot claim that there is a similar advertisement. Hence, stay cannot be granted.

6. In the case of ***K.G. Ashok & Others Vs. Kerala Public Service Commission and Others***, the Hon'ble Supreme Court has held that when the condition mentioned in the advertisement that candidates shall not apply for more than one unit, then it should be followed by the candidates.

7. In the present case, the clause-16 of the advertisement shows that for the same post / same unit, the candidate shall not make more than one applications. That does not mean that he can make thousands applications in other unit.

8. Hence, in view of the Judgment of Hon'ble Supreme Court in the case of ***K.G. Ashok & Others Vs.
