Hence, **Review Application is allowed.**

4. In the present O.A., the original punishment order was passed on 05.01.2005 (A-2, Pages 17 & 18, both inclusives) and on

page 18 the punishment is compulsory retirement to the applicant. The order is signed by Joint Police Commissioner (i.e. सह पोलिस आयुक्त) that time court case was going on against the applicant and final decision in the court case came on 08.12.2017 (A-3, Pages 19 to 30) and as per para no. 15 of Hon'ble High Court Judgment in Criminal Appeal No. 667/2004, applicant was acquitted which is below:-

“15. In the light of discussions supra, I set aside the judgment and order impugned and acquit the accused of offence punishable under section 7, 13 (1) (d) read with section 13 (2) of the prevention of Corruption Act.”

5. The applicant did not prefer any appeal because he was retired on 29.02.2016 as per para 4 of subsequent order which was passed on 24.05.2018 and this order was passed by Deputy Commissioner of Police Head Quarter, Nagpur City and by this order punishment was modified and passed as below:-
