(1) The appointing authority or any authority to which the appointing authority is subordinate or the disciplinary authority or any other authority empowered in the behalf by the Governor by general or special order may place a Government servant under suspension-

(a) where a disciplinary proceeding against him is contemplated or is pending, or

(b) where in the opinion of the authority aforesaid, he has engaged himself in activities prejudicial to the interest of the security of the State, or

(c) where a case against him in respect of any criminal offence is under investigation, inquiry or trial :

Provided that, where the order of suspension is made by an authority lower the appointing authority, such authority shall forthwith report to the appointing authority, the circumstances in which the order was made.

5. It is submitted that from perusal of the impugned order it becomes apparent that in the instant case no report was submitted in respect of the impugned order to the appointing authority i.e. Respondent no.1.
