Heard Shri S.D. Patil, the learned Advocate for the Applicant and Shri A.J. Chougule, the learned Presenting Officer for the Respondents.

This OA can be disposed of by consent in so far as the hearing of the OA is concerned. It is, however, recorded that the learned P.O. does not give any consent for manner in which the OA is to be disposed of.

The relief herein sought is continuation of service of the Applicant in the circumstances that it may not now be necessary to be detailed out. Provisions of Section 3 of the Maharashtra Civil Services (Regulation of Seniority) Rules, 1982 has been invoked. My attention is invited by the learned Advocate for the Applicant to the representation made by him on 15.2.2014, a copy of which is at Exh. 'L' (Page 81 of the paper book). Therein, circumstances were narrated by the Applicant as to how his services were terminated as a result of an order of this Tribunal which came to be set aside by the Hon'ble High Court. Thereafter, he made a representation just referred to, which is still pending.

It, therefore, appears that when this OA was brought on 7.5.2014, a period of six months had not elapsed in so far as decision on the above referred representation was concerned. There is always a possibility of a technical issue being raised in that behalf, and therefore, I accept the request of the learned Advocate for the Applicant to dispose of this OA with directions to decide said representation of the Applicant within six weeks from today. Although the learned P.O. even does not agree for this time limit implying perhaps that he wants longer period
