**ORAL ORDER**

Heard Shri K.G. Salunke – learned Advocate for the applicant, Shri M.P. Gude – learned Presenting Officer for respondent Nos. 1 & 2 and Shri S.D. Joshi – learned Advocate for respondent No. 3.

2. It is admitted fact that the applicant, as well as, respondent No. 3 has applied for the post of Police Patil for village Pathara, District Parbhani and on merit the applicant has been selected and respondent No. 3 is kept at Sr. No. 2. In the meantime, the complaint has been filed against the applicant by respondent No. 3 to the fact that the applicant is not resident of village Pathara, District Parbhani, and therefore, the order is not yet issued in favour of the applicant.

3. From paragraph No. 8 of the affidavit in reply, it seems that the committee has taken a decision and called

enquiry report as regards resident of the applicant from Tahsildar Parbhani vide letter dated 03.03.2016 and the enquiry report is not yet received. The learned Advocates for the respective parties agree that the direction be given to the respondent No. 2 to complete the enquiry within a specified time and the matter can be disposed of with such directions. The learned Presenting Officer submits that four weeks' time may be given for completion of enquiry.

4. In view thereof, I pass the following order: -

### **ORDER**

- (i) The present Original Application stands disposed of with the direction that the respondent No. 2 shall complete the enquiry as regards resident of the applicant within a period of four weeks from the date of this order and shall take necessary action in view of such report.
- (ii) If the applicant is aggrieved by the action of the respondents, he will be at liberty to approach the Tribunal.

(iii) In the facts and circumstances of the case, there shall be no order as to costs.
