2. The present applicant has been held not eligible for the admission to the P.G. course through in-service quota on the ground that the applicant appeared for NEET PG 2022 examination held on 21.5.2022 without obtaining the NOC from the competent authority before the date of the said examination and obtained it on 3.6.2022 i.e. after the date of the said examination.

3. The learned counsel for the applicant invited my attention to the letter dated 11.3.2022 (Annex. A-1 page 21 of paper book) written by the Medical Superintendent of Women's Hospital, Basmat to the Deputy Director of Health Services, Aurangabad Region. The said communication reveals that the applicant had preferred the application on 10.3.2022 and the said application was forwarded by the Medical Superintendent, Women's Hospital, Basmat to the Deputy Director of Health Services, Aurangabad Region on 11.3.2022. The Learned counsel for the applicant submitted that the applicant had applied well within the date before the said examination. He further submitted

that if the delay had occurred on part of the respondents in according such permission the applicant cannot be blamed and cannot be deprived from the right which has accrued in his favour.

4. The learned Presenting Officer opposed for granting interim relief stating that time may be provided to take instructions why for the delay had occurred in according the permission, whether it was because of some lapses on part of applicant or otherwise.

5. The learned counsel for the applicant submitted that in occurrence of delay in granting permission by competent authority there is absolutely no lapse on part of the applicant. The learned counsel for the applicant pointed out that the process of admission has already began and if the candidature of the applicant is not considered he may lose the chance of admission.

6. I have carefully considered the submissions advanced on behalf of the parties. I have perused the documents filed on record. The permission has been refused to the applicant on the sole ground that he did not seek permission before appearing the NEET-PG-2022 examination. By placing on record the document at Annex. A-1 page 21 of paper book, which is referred hereinabove the applicant has made out a prima-facie case evidencing that he had duly applied for permission to appear for NEET-PG-2022 examination in advance by filing application dated 10.3.2022. At present there is nothing contrary on record. The applicant has asserted that the delay in granting the permission has not at his instance. In the circumstances, it appears to me that the applicant has

certainly made out a *prima-facie* case for grant of ad-interim relief in his favour. Hence the following order :-

ORDER

Issue notice to respondents, returnable on 25.11.2022.

2. Tribunal may take the case for final disposal at once and separate notice for final disposal shall not be issued.

3. Applicant is authorized and directed to serve on respondent/s intimation/notice of date of hearing duly authenticated by Registry, along with complete paper book of the case. Respondents are put to notice that the case would be taken up for final disposal at the stage of admission hearing.

4. This intimation/notice is ordered under Rule 11 of the Maharashtra Administrative Tribunal (Procedure) Rules, 1988, and the questions such as limitation and alternate remedy are kept open.

5. The service may be done by hand delivery, speed post, courier and acknowledgment be obtained and produced along with affidavit of compliance in the Registry before due date. Applicant is directed to file affidavit of compliance and notice.

6. If notice is not collected within 7 days or proof of service is not produced before 3 days of the next date, case shall automatically stand dismissed without further reference to the Tribunal.

7. Respondents are directed to provisionally consider the candidature of the applicant for his admission to the PG course through in-service quota, subject to outcome of the present O.A.

Learned Counsel invited my attention to the communication from the Medical Council of India dated 11.12.2017 to buttress his contention that the provision of Senior Residency may not be applied for pre and para-clinical subjects. Learned Counsel pointed out that this Tribunal has in few number of matters filed by similarly situated candidates has earlier granted interim relief. One such order is placed on record by the applicant.

3. Learned Chief Presenting Officer has sought time for filing affidavit in reply on behalf of respondents.

4. After having considered the submissions advanced by the learned counsel for the applicant and after having gone through the documents placed on record, there appears

substance in the contentions raised by the applicant. It is brought to my notice by learned counsel for the applicant that the interviews for filling up the subject posts are in progress and if the interim relief is not granted in favour of the applicant, irreparable loss would be caused to the applicant. In view of the fact that this Tribunal has already taken a view in the earlier matters, I deem it appropriate to pass the following order :-

ORDER

(i) Respondent MPSC is directed to call the present applicant also for interview and keep the result of the said candidate in sealed cover. In the meanwhile if any appointments are made to the post of Assistant Professor in the subject of Pathology, the same shall be subject to outcome of the present O.A.

(ii) In the meanwhile, issue notices to the respondents, returnable on 23.11.2022.

(iii) Tribunal may take the case for final disposal at this stage and a separate notice for final disposal shall not be issued.

(iv) Applicant is authorized and directed to serve on Respondents intimation / notice of date of hearing duly authenticated by Registry, along with complete paper book of case. Respondents are put to notice that the case would be taken up for final disposal at the stage of admission hearing.

Shri S.B. Solanke, learned Counsel for the applicants and Shri M.S. Mahajan, learned Chief Presenting Officer for the respondents, are present.

2. The applicants have circulated the present Original Application for interim relief. Learned Counsel for the applicants pointed out that the respondents have started implementing the orders of reversion and if the reversion takes place, the purpose of filing the present Original Application would be frustrated. Learned Counsel in the circumstances has prayed for interim relief in terms of prayer clause E,F and G.

3. Learned C.P.O. has opposed for granting any such relief. Learned C.P.O. pointed out that the orders are passed by the respondents in consonance with the decision rendered by this Tribunal in O.A.No.198/2021 with O.A.No.204/2021 delivered on 14.01.2022.

4. Learned Counsel for the applicants sought to contend that when the aforesaid Original Applications were heard by this Tribunal, some of the relevant judgments like the judgment delivered by the Hon'ble Bombay High Court, Bench at Aurangabad in Writ Petition Nos.4778 and 5182 of 2013 (Abdul Saleem Siddiqui Vs. State of Maharashtra

and Ors.) decided on 17.02.2004 was not brought to the notice of this Tribunal. Learned Counsel further submitted that subsequently the rules have also been amended and the said fact was also not brought to the notice of this Tribunal. Learned Counsel for the applicants further submitted that the decision rendered by this Tribunal in O.A.No.198/2021 with O.A.No.204/2021 has been challenged before the Hon'ble High Court and the said Writ Petition is pending for consideration of the Hon'ble High Court. Learned Counsel therefore prayed for interim relief.

5. I have considered the submission advanced by learned Counsel appearing for the applicants. Though it has been brought to my notice that the decision rendered by this Tribunal in aforesaid O.As. has been challenged before the Hon'ble High Court, nothing has been submitted on record or no such statement has been made that in the said Writ Petition the Hon'ble High Court has stayed the implementation of the said order. However, it is the contention of the learned Counsel for the applicants that some change has occurred in the rules which may have material impact on deciding the seniority of the applicants in present matter. At present, however, I may not take any view contrary to the view earlier taken by the Division Bench in the order passed on 14.01.2022 in the above referred O.As. At this juncture, to safeguard the interest of the applicants, it is clarified that in the meanwhile, if the impugned orders get implemented, the same shall be subject to outcome of the present Original Application.
