JUDGMENT

- 1. The applicants prays that the final seniority list of Supply Inspecting Officer, Grade-B, (Gazetted) dated 27.1.2020 and 12.2.2020 be quashed and set aside the Respondents be directed to prepare the seniority list of Supply Inspector, Grade-B (Gazetted) at the Revenue Divisional level, as the present seniority list was prepared at State level. However, as per the prevalent Recruitment Rules the seniority list should have been prepared at Divisional level and accordingly promotions are to be given at Divisional level.
- 2. Learned counsel for the applicants submits that if the seniority list is prepared at State level, then the applicants would suffer. Learned counsel for the applicants pointed out that since 2020 promotions to the post of Supply Inspecting Officers are not given. Learned counsel for the applicants submitted that the Respondents should not have prepared the seniority list at State level when there are specific directions given by the G.A.D.
- 3. Learned C.P.O relied on the affidavit in reply on behalf of Respondents no 1 & 2 dated 16th November, 2021, filed by

Vandana S. Sangar, that the new Recruitment Rules for the post of Supply Inspecting Officer/Zonal Officers are not prepared and they are in the pipeline. Learned C.P.O submitted that she is unable to tell when they are going to be prepared and finalized. Along with

the affidavit in reply the noting of G.A.D dated 4.5.2018 is also

produced.

4. However, as on today, as per the present Recruitment Rules of 1984, the seniority list of the officers are to be prepared at Divisional level. After hearing both the sides and we have gone through the affidavit in reply and noting of G.A.D dated 4.5.2018, we are of the view that the seniority list is to be prepared of the

officers as per the existing Recruitment Rules of 1984.

5. In view of the above, nothing remains in both the applications. Misc Application and Original Application stands

disposed of.

6. The Original Application is allowed. The seniority list of Supply Inspecting Officer, Grade-B (Gazetted) dated 27.1.2020 and 12.2.2020 prepared by the Respondents is quashed and set aside."
